

CHIMNEY PEAK WILDERNESS

13,105 Acres

**Designated October 31, 1994 by the California Desert Protection Act
Public Law 103-433**

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Chimney Peak Wilderness Area located in Tulare County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

From the township corner of Ts. 23 and 24 S., R. 37 E., Mount Diablo Meridian, on the range line between Rs. 36 and 37 E., said point being the point of beginning;

thence northerly on the range line between T. 24 S., R. 36 and T. 23 S., R. 37 E. to point 1, the intersection of a line parallel with and 100 feet southerly of the centerline of Long Valley Loop Road;

thence southeasterly, parallel with and 100 feet southerly of said centerline to point 2, the intersection of a line parallel with and 30 feet westerly of the centerline of a southeasterly bearing jeep trail, located in the northeast 1/4 of section 6, T. 24 S., R. 37 E.;

thence southeasterly, parallel with and 30 feet westerly of said centerline to point 3, the intersection of the east-west centerline of the southwest 1/4 of section 5;

thence South to point 4, the intersection of a line parallel with and 100 feet westerly of the centerline of Canebrake Road;

thence southwesterly, parallel with and 100 feet northwesterly of said centerline to point 5, the intersection of the east-west centerline of the northwest 1/4 of section 25, T. 24 S., R. 36 E.;

thence West on said line to point 6, the line between sections 25 and 26;

thence South on said section line to point 7, a line parallel with and 100 feet northerly of the centerline of the Long Valley Loop Road;

thence westerly, changing to northwesterly, changing to northeasterly, changing to southeasterly on a line parallel with and 100 feet northerly, changing to northeasterly, changing to southeasterly, changing to northeasterly of the centerline of the Long Valley Loop Road to point 8, the intersection of a line parallel with and 30 feet southwesterly of the centerline of a jeep trail, said intersection having NAD 1927 coordinates of 35°53'51" N. latitude, 118°05'58" W. longitude, as scaled from the U.S.G.S. 7.5 minute Quadrangle "Sacatar Canyon, Ca.", Provisional Edition 1986;

thence southwesterly to point 9, a knob having NAD 1927 coordinates of 35°53'36" N. latitude, 118°06'08" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Sacatar Canyon, Calif.", Provisional Edition 1986;

thence southeasterly to point 10, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail;

thence southeasterly, parallel with and 30 feet westerly of said centerline to point 11, the intersection of a line parallel with and 30 feet northerly of the centerline of a jeep trail;

thence southwesterly to point 12, a knob having NAD 1927 coordinates of 35°53'19" N. latitude, 118°06'10" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Sacatar Canyon, Calif.", Provisional Edition 1986;

thence southerly to point 13, a saddle having NAD 1927 coordinates of 35°52'48" N. latitude, 118°06'07" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Sacatar Canyon, Ca.", Provisional Edition 1986;

thence easterly to point 14, said point having NAD 1927 coordinates of 35°52'47 1/2" N. latitude, 118°05'29" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Sacatar Canyon, Calif., Provisional Edition 1986;

thence southwesterly to point 15, said point having coordinates of 35°52'40" N. latitude, 118°05'36" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Sacatar Canyon, Calif.", Provisional Edition 1986;

thence southeasterly to point 16, said point having coordinates of 35°52'32" N. latitude, 118°05'20" W. longitude as scaled from the U.S.G.S. 7.5 minute quadrangle "Sacatar Canyon, Calif.", Provisional Edition 1986;

thence southwesterly to point 17, said point having coordinates of 35°52'27" N. latitude, 118°05'35' W. longitude as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence southeasterly to point 18, the intersection of the thread of a drainage, said intersection having NAD 1927 coordinates of 35°52'12" N. latitude, 118°05'20" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence East to point 19, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail, said intersection having NAD 1927 coordinates of 35°52'12" N. latitude, 118°04'50" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence southeasterly, parallel with and 30 feet southwesterly of said centerline to point 20, a point perpendicular to the jeep trail centerline at its terminus near a prospect said terminus having a NAD 1927 longitude line of 118°04'31½" W. , as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence southeasterly to point 21, a peak having an elevation of 7388 feet, as shown on the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence southeasterly on said ridge to point 22, the top of a knoll having NAD 1927 coordinates of 35°51'06" N. latitude, 118°04'05" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence East to point 23, the intersection of the thread of a drainage, said intersection having NAD 1927 coordinates of 35°51'06" N. latitude, 118°03'41" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence northeasterly to point 24, a knob on ridge, said knob having NAD 1927 coordinates of 35°51'26" N. latitude, 118°03'26" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence easterly on said ridge to point 25, a saddle located near the 7400 foot elevation contour line, said saddle having NAD coordinates of of 35°51'27" N. latitude, 118°03'10" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence northeasterly to point 26, a knob on a ridge, said knob having NAD 1927 coordinates of 35°51'40" N. latitude, 118°02'38" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence northwesterly to point 27, a knob on a ridge, said knob having NAD 1927 coordinates of 35°52'00" N. latitude, 118°03'02" W. longitude, as scaled from the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986;

thence northwesterly along the ridge, to point 28, the intersection of the east/west centerline of section 1, T. 24 S., R 36 E.; if the end point of this ridge, defined as the top of knob having an elevation of 7538 feet, as shown on the U.S.G.S. 7.5 minute quadrangle "Lamont Peak, Calif.", Provisional Edition 1986, lies south of said east/west centerline, extend a line North from knob to intersection;

thence easterly on the east/west centerline of section 1 to point 29, the 1/4 section corner of section 1 only, on the range line between T. 24 S., Rs. 36 and 37 E.;

thence northerly on said range line to the point of beginning.

END OF DESCRIPTION

The above description containing approximately 13,105 acres utilizes the Lamont Peak, Sacatar Canyon, and White Dome 7.5 minute quadrangle maps prepared by the U.S.G.S. The boundary calls listed herein are in part a result of scaling distances from said quadrangle maps and are not a result of survey. All courses have been depicted upon the above mentioned quadrangle maps and are made a part of this official record. Acreage is calculated from the BLM California State Office ArcInfo wilderness coverage.

I hereby certify the legal description and map herewith represent the location of the boundary of the Chimney Peak Wilderness area designated by the California Desert Protection Act, Public Law 103-433, dated October 31, 1994.
