**Rennie Ferris:** PAC meeting at Newport and shared the knotweed program. Rennie ended up being the licensed leader for this project. Fairly affective and based on other results, our results of the project will show next year.

**Mike Wilson:** Pass

**Mike Kennedy:** Everyone is invited to the restoration project at Chinook Winds, afternoon of November 20. The Siletz Tribe POW WOW will be in the evening.

**Rosemary Furfey:** The public comment period for Coho salmon is still open. It is on the web page. The Coho recovery plan group is meeting November 15 & 16 in Roseburg. NOAA fisheries critical habitat has been issued. Rosemary will give a briefing when it comes out.

**Denis Williamson:** Owl study: they are evaluating it, The RMP steering committee is talking about collaboration models, budget etc.

**Jose Linares:**

Recreation has a new facility at Devils Churn. Fee demo legislation looks like were going to get some permanent legislation.

Facilities lease is coming up, we are competing for a new building in Corvallis but not sure where at this time.

South Zone office, We are trying to figure out where the main office will be located for the South Zone Ranger District. The decision of where to locate the office is getting closer. There are three options, we have been meeting with the local folks and Linda Goodman will be making the final decision soon.

FY04 timber accomplishments were 34mmbf board feet. We left 12 mmbf for fiscal year 15.

**Barry Wulff:** Sierra Club locally has been active with five workdays in the spring and two workdays in the fall. We averaged between 12 and 24 people each workday. This fall we worked for the city and county. Next spring we hope to work at Alsea Falls. We will run about 70 outings, approximately 1000 people, walking on the dirt roads and will do it again in the spring. We would like to take folks on hikes (Sierra Club), we need to keep our trails up.

**Kim Gossen:** Wasson Creek Roadless area, was a push to build a trail along this creek, and no longer resides on Coos Bay BLM web site. We never hear from Coos Bay BLM; maybe our province doesn't go that far. Could be part of the trails (Wasson Creek), She doesn't like getting single sided copies.
