### **A. Background**

*Proposed Action Title: Fish Guide Outfitter Special Recreation Permit (SRP) Renewal*

*Location of Proposed Action: Yakima River Canyon, T15N, R19E, S4,16,28*

*Description of Proposed Action: Randal Sumner operates Blue Skies Fishing, a fishing outfitter/guide service in the Yakima River Canyon. He runs guided fishing float trips (estimates 2 anglers per boat) on the Yakima River, throughout the year. Randal is applying for a Special Recreation Permit to use BLM boat accesses at Lmuma Creek, Big Pines and Roza recreation sites to launch and take out his non-motorized boat.*

Randal Sumner has had a SRP with BLM for the past 5 years. He has provided proof of insurance, paid the \$90 SRP filing fee and filled out the SRP application form. Randal has also been provided with information on BLM's SRP policy. He and/or employees working for him will have the SRP authorization with them during their activities and will be checked on by BLM employees to ensure compliance.



(Umtanum, Lmuma Creek, Big Pines, and Roza Recreation Sites)


