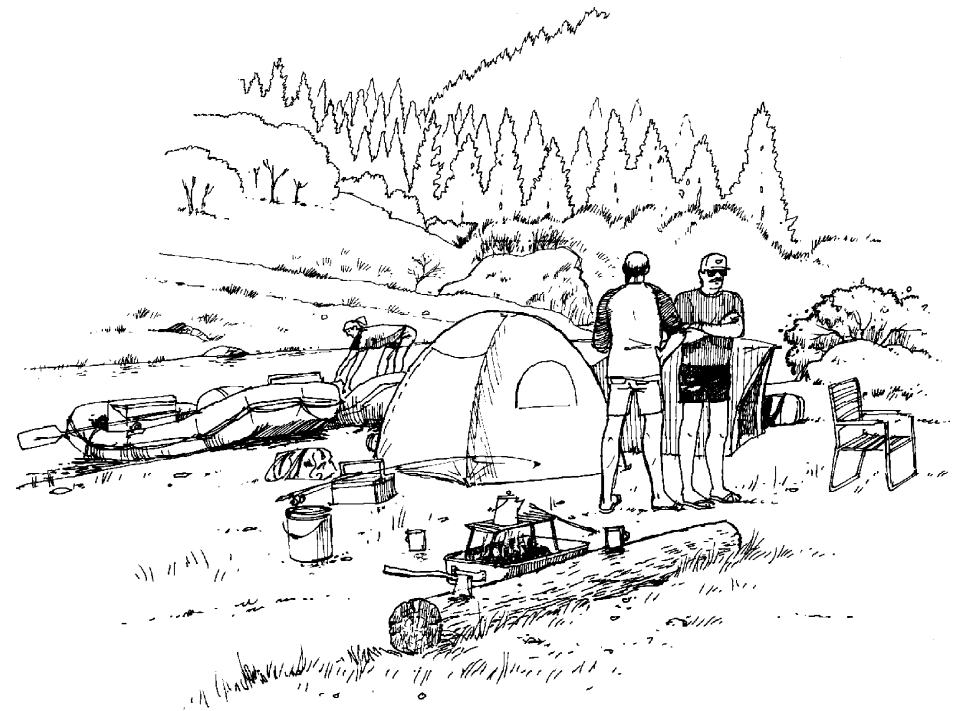

# Leave No Trace on the Rogue

Thousands of people visit the Rogue River canyon each year. Everyone entering this area wants to see the river in a clean and natural state. Please do your part to protect the vegetation and wildlife, as well as preserve the wild river experience. Be courteous to others on the river and at boat ramps. Practicing the following Leave No Trace principles will help everyone have a better trip on the Rogue.

**Camping courtesy** includes selecting a campsite that fits the size of your group. Campsites are available on a first-come, first-served basis.

**Human waste disposal** is a concern on the river. **All parties are required to carry a portable toilet.** Take care of your waste by using your portable toilet when stopping at a site without a toilet. Check with the Smullin Visitor Center at Rand to be sure your portable toilet system meets the minimum requirements for river running.

**Fire pans or fire blankets are required year-round for all campfires within 400 feet of the river.** Burn small pieces of dead and down wood only. Carry out all excess charcoal, ashes, and burnt wood. A better alternative is to use a campstove instead of a fire. This is a safer and cleaner choice and won't damage the land. **Contact the Smullin Visitor Center at Rand for the latest fire restrictions or closures.**

**Waste water** should be strained to remove solid food particles. Carry out food particles with your trash. Waste water, including bathing water, may be thrown directly into the main river current, never in an eddy. Do not bathe or wash near side streams. Choose a biodegradable soap and use it sparingly, if at all.

**Bears** have become bold and unafraid of humans due to lack of care in safeguarding food and garbage. Save your dinner by keeping a clean camp and securing all coolers, food, trash, and cooking supplies. Use electric fences located at sites commonly visited by bears (see map). Keep the wild Rogue bears wild!

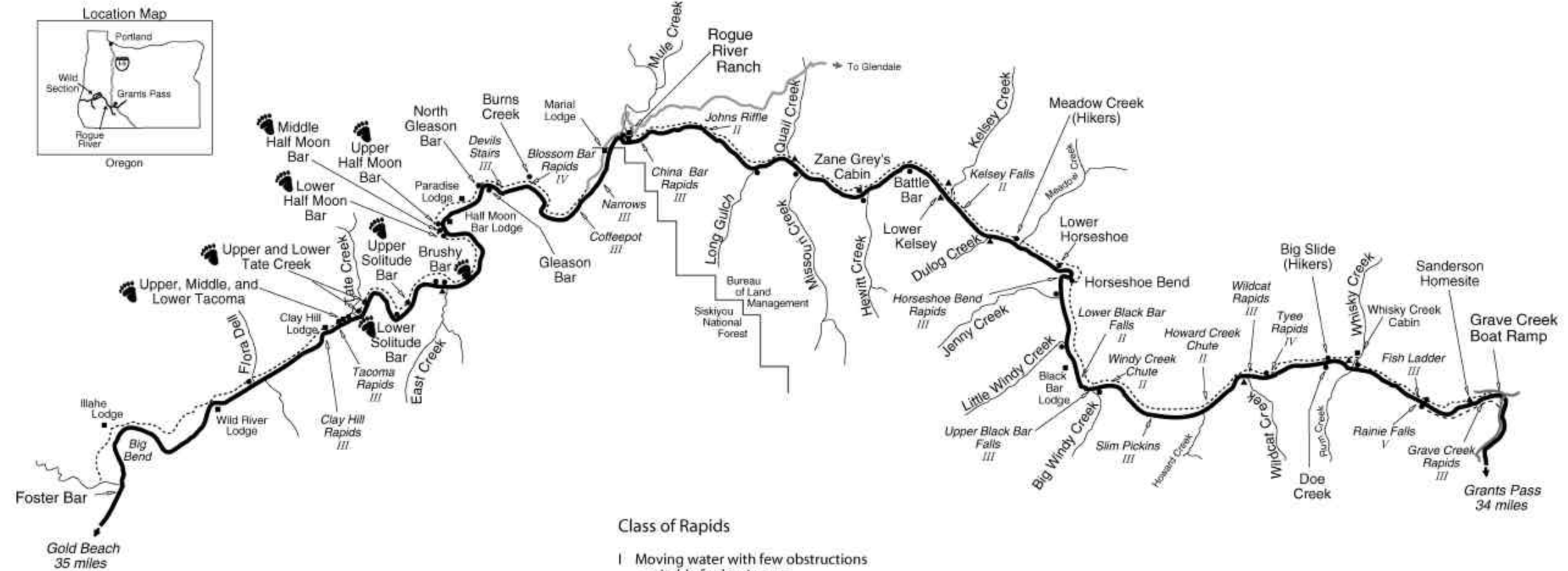

# Wild Rogue River



## Class of Rapids

- I** Moving water with few obstructions
  - suitable for beginners
- II** Small waves and turbulence
  - some obstacles and maneuvering
  - intermediate skill level necessary
- III** Medium size waves, strong hydraulics
  - considerable maneuvering and scouting required
  - experience necessary
- IV** Large powerful waves, powerful turbulence and hydraulics
  - precision maneuvering and scouting required
  - considerable skill needed
- V** Extreme turbulence, very large waves, very narrow and congested passage, rescue difficult
  - experts only
- VI** Very dangerous - limits of possibility
  - attempting at this level is life threatening
  - experts do not attempt
