**Proposed Action Title/Type:** Guided Wilderness Tours in the National Petroleum Reserve-Alaska (NPR-A) (2930.00).

**Description of Proposed Action:** The applicant David Perry, with Sierra Club Outings has requested authorization for field activity access and landing by a fixed wing aircraft on lands within the southern portion of the National Petroleum Reserve Alaska (NPR-A) to conduct a guided wilderness tour.

The trip would be an 11 day overnight backpacking trip from June 14- June 24<sup>th</sup>, 2011. There would be a total of 10 people including 2 guides and 8 participants. Access to and from the area would be via a charter flight with Golden Eagle Outfitters of Kotzebue. They would fly to Iligluruk Creek and land on an unimproved gravel bar deemed by the pilot to be suitable for tundra tire landings and take-offs. for drop off and be picked up near Kokolik and Illigluruk Rivers on state land. Due to aircraft capacity limitations there would be 3 trips in and 3 trips out to get everyone and their gear in and out of the area. They would be carrying 220-330 ounces of white gas for their stoves.

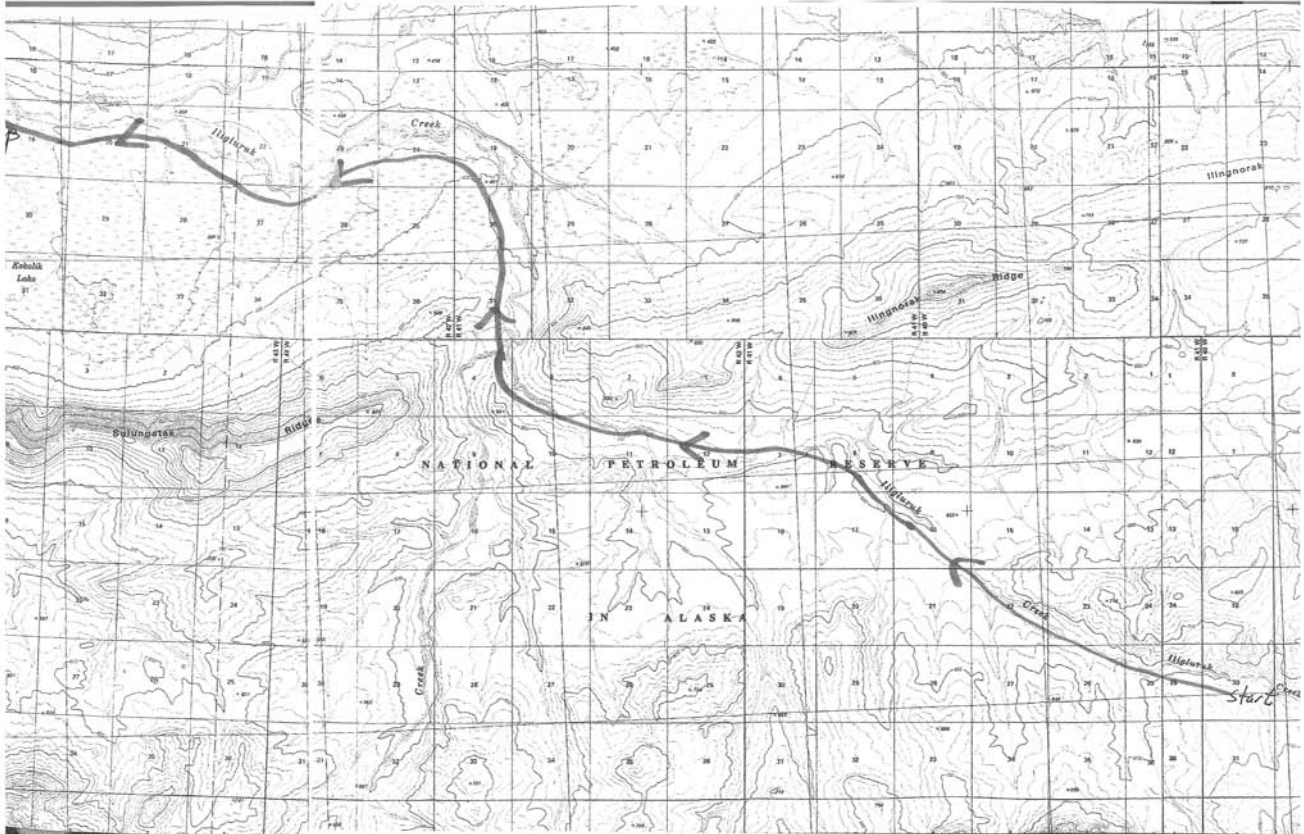


Figure 1: Applicant submitted map of the trip route.
