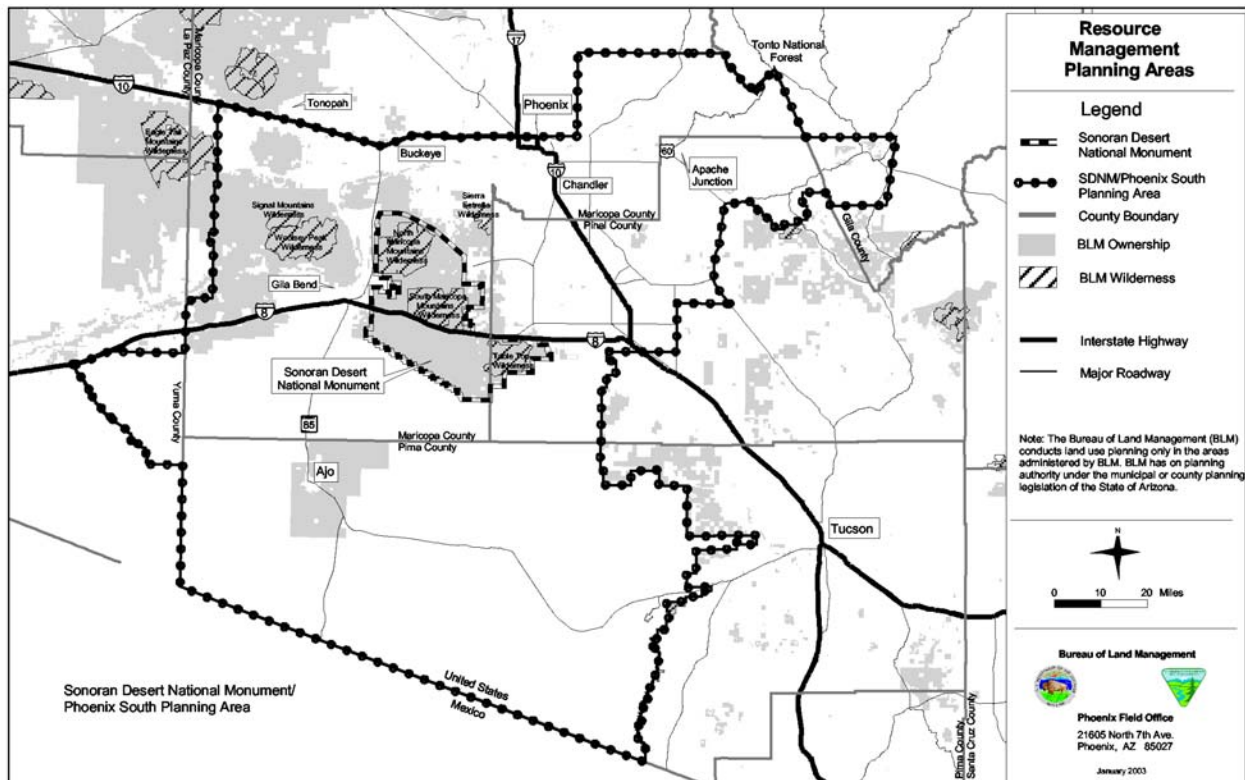

Welcome to planning for the public lands.

Resource management planning is the way the Bureau of Land Management (BLM), working with the public, decides how to manage the public lands for the future. This planning process will take a comprehensive look at the management of about 1.42 million acres of the BLM-administered public lands in two areas:

- Sonoran Desert National Monument
- “Phoenix South” - public lands south of Phoenix

This is the first in a series of planning bulletins that will familiarize you with the planning process and planning areas. We are also asking that you help us out by identifying management goals, issues, and concerns that you think should be addressed in the plans. The enclosed *Planning Worksheets* are one way we will gather ideas. Another is through a series of open houses; the dates and locations are listed inside this bulletin. We encourage you to be a part of this very important process; we want to hear your ideas. Thank you for joining us in planning for the future of our public lands.



Why are these plans needed?

The Sonoran Desert National Monument was designated in January 2001, with the signing of Presidential Proclamation 7397. The monument encompasses approximately 486,000 acres of Sonoran desert landscape. It includes a rich diversity of plants and animals, as well as many significant archaeological and historic resources. The purpose of the monument designation is to protect the area's natural, cultural, scientific and educational resources. Establishment of the national monument necessitates the development of a Resource Management Plan (RMP).

The metro-Phoenix area has experienced significant growth in recent years, and is expected to continue to grow rapidly in the future. Associated with this growth is increased use of and interest in the public lands. The public lands have important wildlife, scenic, cultural, recreation, vegetation, wilderness, grazing, mineral, and other values. The increased pressure on public lands for recreation, rights-of-way, mineral rights, and other purposes resulting from population increases requires the BLM to readdress its land use plan decisions.

Project Schedule

This schedule shows the major planning tasks and opportunities for public involvement. Adjustments to this schedule will occur depending on final budget appropriations in 2003, as well as due to issues identified as we proceed through the planning process and other reasons. What are we doing?

We will be developing two Resource Management Plans, one for each of the planning areas. We will also be developing an environmental impact statement (EIS). The EIS will assess possible environmental, social, and economic effects of different management alternatives for public lands within the two planning areas.

The planning process is expected to take about three years and involves several steps. There will be many opportunities for public involvement, beginning with the first step, *Public Scoping and Issue Identification*, which this bulletin addresses. We encourage you to get involved in this process to help us identify what issues the plan should address by sending us comments and attending the public meetings. Additional opportunities for public involvement will continue as we develop the management alternatives to address the issues identified during scoping and when we issue the draft plan. At each stage, the BLM will hold public meetings to ensure public involvement. The project schedule is shown below.

Staying involved

The BLM is committed to providing opportunities for the public to be meaningfully involved in the resource management planning and environmental review process. We will work closely with communities and interested citizen groups to identify management decisions best suited to the needs of the public. The BLM is also seeking participation from tribal, state, and local governments. In order to create a shared vision for the planning areas, we will use an interactive, dynamic process that will allow you to participate in developing alternative concepts for managing public lands.

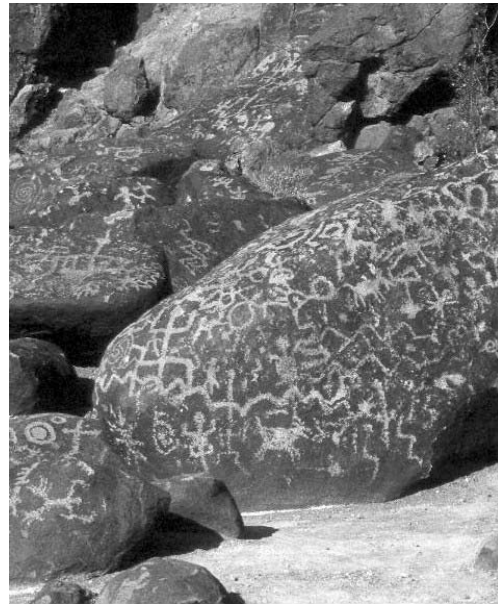
