

1 Prejudice pursuant to Federal Rule of Civil Procedure 41(a) and in support thereof, state as
2 follows:

3 1. The Parties have reached settlement on all issues raised in this matter, as embodied in
4 the Stipulated Settlement Agreement filed concurrently with this motion.

5 2. Dismissal of this case with prejudice is appropriate pursuant to Federal Rule of Civil
6 Procedure 41(a).

7 3. The Parties request that the Court retain jurisdiction over this action until the Bureau
8 of Land Management has issued a Record of Decision for the Sonoran National Monument
9 Resource Management Plan for the limited purpose of enforcing the terms of the settlement
10 agreement.

11 WHEREFORE, the Plaintiff and Federal Defendant agree that an order incorporating the terms
12 of the settlement agreement and dismissing this case with prejudice is appropriate and
13 respectfully request that the Court enter such Order.
