Grazing preference transfer will be from the current lease holder Big Mountain Ranch, LLC to William (Bill) Robinson. The base property lease agreement between these two parties is from October 25, 2003 until October 15, 2008.

Along with the transfer, the Bureau of Land Management (BLM) will combine the three allotments into one BLM lease. The combined lease will not change any of the conditions on the current leases.
