Subject: RAC Nomination Process

Thank you for your interest in the Idaho Bureau of Land Management (BLM) Resource Advisory Councils. The RACs serve an important role in the management of public lands and your willingness to lend your time, knowledge and expertise is greatly appreciated.

Nomination Process

In Idaho, the BLM has four Districts and each has a RAC to serve them by making recommendations to the agency on natural resource matters. If you know the BLM District in which you reside, please contact the RAC coordinator for that area to initiate your nomination process. He or she will be able to guide you through the process and answer your questions. If you are uncertain of the BLM District that manages the public land in your area, please contact the State RAC coordinator and she will assist you. All contact information is below.

Required Nomination Materials

The application materials for RAC appointments include a completed **Background Information Nomination Form** and a **letter of reference** from the interest you wish to represent on the RAC. The *Background Information Nomination Form*, or application form, is available through all coordinators or on the web at www.blm.gov//id/st/en.html. Letters of reference are generally sent from the interest, usually an organization or agency, you wish to represent. For example, if you want to represent commercial recreation, you would need a letter from a recognized organization in the state that operates on behalf of commercial recreation. The goal is to ensure that the interest you choose to represent on the RAC supports your nomination.

Where to submit your nomination form: Nomination forms and reference letters may be submitted through your local BLM RAC Coordinator or, if time is short, may be sent directly to Mikell Galloway, BLM Idaho State Office, 1387 South Vinnell Way, Boise, Idaho 83709.

Materials Deadline

The 2008 nomination period closes **April 14, 2008**. All application packages must be in to the State RAC Coordinator, Mikell Galloway, in the Idaho State Office by that date. Telephone: (208) 373-3800. E-mail: mikell_galloway@blm.gov.

Review and Appointment Timeline

All RAC nominations undergo an extensive review, at various levels of the government, prior to appointments being made by the Secretary of the Interior. This review process takes several months to complete.

April 15 – June 5	District Office, Idaho State Office and Governor’s Office review
June 6	State RAC nomination package submitted to BLM Washington D.C. Office
July – September	The State RAC nomination package is reviewed by a variety of BLM and Departmental offices, congressional staff, and a White House committee. The package ultimately is forwarded to the Office of the Secretary of Interior for final review and appointment.
September, October	RAC appointments made by the Secretary of the Interior and letters sent to new appointees

Appointment Terms

RAC members are generally appointed to fill a three-year term. This staggers the composition of the RAC so that five positions expire each year. Applicants will receive a letter directly from the Secretary of Interior's Office announcing their appointment.
