Continuation of Current Management (This was the No Action alternative)


Rational for Decision: The decision to authorize the proposed action as outlined in Alternative 2 of the EA satisfies the Bureau's concerns, objectives, and obligations, has been determined to be in the public interest, and does not result in any undue or unnecessary environmental degradation. This decision is in conformance with the Judith, Valley, Phillips Resource Management Plan, approved September 1994.

Authority: This action is in accordance with 43 CFR 4130.2, 4110.2-2(a), 4130.3, 4180.1 and 4180.2(c).

Finding of No Significant Impact: Based on the analysis of the potential environmental impacts contained in the Petrolia Watershed Plan, this activity is not a major federal action which will significantly affect the quality of the human environment, therefore, an Environmental Impact Statement is not required.
