When offered, public comment periods are initiated through official notifications (i.e., direct mailing, local and/or state newspapers, Federal Register notices). However, interested publics are also encouraged to check this site frequently to ensure adequate time for comment on specific NEPA documents, especially in the case of projects without a planned formal public comment period. These comments will be considered during the NEPA analysis and decision-making process for the applicable project, contingent on the project's schedule status.
