MEMORANDUM FILE NO 9630 (942), ARIZONA, DATED 1/29/1992, OFFICIALLY CANCELLED THE SURVEY FOR 1N 6W OF THE NAVAJO SPECIAL MERIDIAN, ARIZONA, WHILE THE REMAINING SURVEYED AND PARTIALLY SURVEYED TOWNSHIPS OF THE NAVAJO SPECIAL MERIDIAN, ARIZONA, WERE OFFICIALLY CANCELLED PER MEMORANDUM FILE NO 9630 (942) DATED 11/28/1994;
