THE AFFECTED PORTIONS OF THE SUSPENDED PLATS WERE CANCELLED UPON ACCEPTANCE OF THE NEW SURVEY. THE SURVEYED AND PARTIALLY SURVEYED TOWNSHIPS OF THE NAVAJO SPECIAL MERIDIAN, ARIZONA, WERE OFFICIALLY CANCELLED PER MEMORANDUM FILE NO 9630 (942), ARIZONA, DATED 11/28/1994; | |
