Young & Sons light mountain transits Now 0592 and 0540, each equipped with full vertical circle and Smith solar attachment; unless otherwise specified, all azimuth determinations are accomplished with the solar attachment.

Field Test of Instrument No. 8592 by W. H.

Thorn, U. S. Cadastral Engineer.

December 17, 1922: I examine the adjustments of the transit and correct all errors; then, to test the solar apparatus, by comparing its indications, resulting from observations made during a.m. and p.m. hours with a meridian established by Polaris observation, I proceed as follows:

At camp near the cor. of secs. 15, 16, 21 and 22, 7. 7 N. R. 6 W., G. & S. R.B. and M., Arizona, lat. 33°56 IN. long. 1-12°52 W. using the meridian established by Ty White, U.S. Transitman, as hereinafter described, at 9 hrs. 0 m., a.m., 1.m.t., I set off 33°56½ N. on the lat. arc; 23°18½ 'S. on the decl. arc; and determine a meridian with the solar, which I find to agree with the true meridian.

At apparent noon, with the lat. arc unchanged, I observe the sun on the meridian; the resulting reading of the decl. arc is 23°20'S., which agrees with the computed

decl. of the sun.

At 3 hrs. 0 m., p.m., l.m.t., with the lat. arc unchanged I set off 23°19½.s. on the decl. arc, and determine a meridian with the solar, which I find to agree with the true meridian.

As all of the solar observations during the usual hours of solar work come within 1'30" of the true meridian, I conclude that the adjustment of the instrument is

satisfactory.

Unless otherwise specified, all measurements are made with a Lufkin steel tape, 5 chs. in length, compared with a Lufkin 1 ch. standard steel tape and found correct. The measurements are made on the slope, the vertical angle determined and the slope measurements properly reduced to true horizontal distances.

Field Test of Instrument No. 8540 by Ty White, U. S. Transitman.

December 16, 1922:At camp near the cor. of secs. 15, 16, 21 and 22, T. 7 N., R. 6 W., G. and S. R. 3. and M., Arizona, lat. 33°56¹ 'N., long. 112°52¹ 'W., I examine the adjustments of the transit and correct all errors; then to test the solar apparatus, by comparing its indications, resulting from observations made during a.m. and p.m. hours with a meridian established by Polaris observation, proceed as follows:

With the telescope in the meridian, and elevated to the sun's altitude, I observe the sun's transit for time, noting the watch time of transit of each limb;

Mean watch time of apparent noon 12 hrs. 5 m.3 sec.

Watch fast of local mean time 0.5 m.

At the same station, at 4 h 53 m. p.m., l.m.t., I make an hour angle observation on Polaris east of the meridian, making four observations, two each with the telescope in direct and reversed positions, and mark the mean point in the line thus determined on a peg driven firmly in the ground, 5 chs. N.

Watch time of observation, mean of four readings = 4 hrs. 58 m.

I lay off the azimuth of Polaris; 57 10 "to the west, and mark the meridian thus determined by a tack in a peg driven firmly in the ground, 5 chs. N.

December 17, 1922. At 9h.0m.a.m., l.m.t., I set off 33° 56½'N.on the lat.arc; 23°18½'S. on the decl. are; and determine a meridian with the solar, which I find to agree with the true meridian.

At apparent noon, with the latitude arc unchanged, I observe the sun on the meridian; the resulting reading of the decl.arc is 23°20'S., which agrees with the computed decl.of the sun.

At 3h.0m.p.m., l.m.t., with the lat.arc unchanged, I set off 23°19½'S. on the decl.arc; and determine a meridian with the solar, which I find to agree with the true meridian.

As all of the solar observations during the usual hours of solar work come within 1'30" of the true meridian, I conclude that the adjustment of the instrument is satisfactory.

Unless otherwise specified, all measurements are made with a Lufkin steel tape, 5 chs. in length, compared with a Lufkin 1 ch.standard steel tape, and found correct. The measurements are made on the slope, the vertical angle determined, and the slope measurements properly reduced to true horizontal distances.

Resurvey of the East bdy of Township 7 North Range 6 West.

Chains.

The range line, bet. Ts. 7 and 8 N., Rs. 5 and 6 W.was surveyed by S.W. Foreman, U.S.D.S. in 1871 and 1872, establishing all corners thereon common to sections and quarter sections on both sides of the line. This range line thru. T.8 N. was resurveyed in 1909 by J.F. Hesse, U.S.D.S., reestablishing all corners on the line including the township cors., with a common reference to the areas on both sides of the line. No subsequent retracement or resurvey of the range line in T.8 N., and no retracement or resurvey of the range line in T.7 N. is of record.

In 1914, W.H. Thorn, U.S.S., and W.K. Kierulff, U.S. T. surveyed the S. and W. boundaries and subdivision lines of T.8 N., R.6 W., closing the S. bdy. and subdivision lines of said Tp. against this range line in T.8 N., and changing the corner of Ts. 7 and 8 N., Rs.5 and 6 W. to refer to Ts. 7 and 8 N., R.5 W. only, and all corners on the range line N. therefrom to refer to areas E. of the line only. The closing cor. of Ts. 7 and 8 N., R.6 W.

The following notes describe a resurvey of the East bdy. of T.7 N., R.6 W., combined with a resurvey of the West bdy. of T.7 N., R.5 W. as two sets of corners are required on the range line owing to the offset developed by the closing of the township boundary between Ts. 7 and 8 N., R. 6 W.

Retracement for Resurvey.

From the closing cor. of Ts. 7 and 8 N., R.6 W., S.0°1'W. (record course) on random line. Intersect the cor. of Ts. 7 and 8 N., R.5 W.

South (record course) on random line, searching diligently at record intervals for the original corners. Fail to find trace of any old corner and at

find trace of any old corner; and at (Record dist.) Diligent search in this vicinity failing to reveal any trace of the old township cor., set temp.cor.of Ts.6 and 7 N., R.5 W.

The range line thru. T. 6 N., has never been surveyed; therefore in order to locate an old corner which can be used as a basis for reestablishment of this Tp. cor. by proportionate measurement, begin at the temp. Tp. cor., and retrace the South bdy. of T. 7 N., R. 5 W., searching diligently at record intervals for the old corners. Fail to find any trace of any corner on this line; therefore, abandon the attempt to reestablish the corner of Ts. 6 and 7 N., R. 5 W. by proportionate measurement between old corners, and return to the closing corner of Ts. 7 and 8 N., R. 6 W., and make an independent resurvey of the line as described as follows:

The closing cor. of Ts.7 and 8 N., R.6 W. is an iron post, 3 ins. in diam., projecting 24 ins. above ground, firmly set in ground and mound of stone, properly marked on brass cap, and witnessed by a mound of stone, W. of cor. No bearing trees.
