



Surveys herein described were executed on dates shown on diagram on page 2 hereof, by Theodore Vander Meer, U. S. Transitman, using Young and Sons light mountain transit No. 8389, equipped with a full vertical circle and Smith solar attachment; unless otherwise specified, all azimuth determinations are accomplished with the solar attachment.

March 14, 1925: Examine the adjustments of the transit and correct all errors; then to test the solar apparatus by comparing its indications, resulting from observations made during a.m. and p.m. hours with a meridian established by Polaris observation, proceed as follows:

At camp near center of sec. 5, frac. T. 3 S., R. 32 E. (unsurv.) G. and S.R. Base & Meridian, Ariz., latitude  $33^{\circ}12'N.$ , longitude  $109^{\circ}42'W.$ , at 8h 2.3 m p.m., l.m.t., observe Polaris at western elongation, making four observations, two each with the telescope in direct and reversed positions, and mark the mean point in line thus determined on a peg driven firmly in the ground 5 chs. northerly.

Azimuth of Polaris at western elongation;  $1^{\circ}18'33''$

March 15, 1925: At 7h 45m, a.m., l.m.t.; lay off the azimuth of Polaris,  $1^{\circ}18\frac{1}{2}'$  to the east and mark the meridian thus determined by a tack in a peg driven firmly in the ground, 5 chs. N.

At 8h 0m., a.m., l.m.t., set off  $33^{\circ}12'N.$  on the lat. arc,  $2^{\circ}8\frac{1}{2}'S.$  on the decl. arc and determine a meridian with the solar, which is found to agree with the true meridian.

At apparent noon, with the lat. arc unchanged observe the sun on the meridian; the resulting reading of the decl. arc is  $2^{\circ}5\frac{1}{2}'S.$ , which agrees with the computed decl. of the sun.

At 4h 0m., p.m., l.m.t., with the lat. arc unchanged, set off  $2^{\circ}00\frac{1}{2}'S.$  on the decl. arc and determine a meridian with the solar, which is found to agree with the true meridian.

As all of the solar observations during the usual hours of solar work come within  $1'30''$  of the true meridian conclude that the adjustments of the instrument are satisfactory.

Unless otherwise specified, all measurements are made with a Lufkin steel tape, 5 chs. in length, compared with a Lufkin 1.00 ch. standard steel tape and found correct. The measurements are made on the slope, the vertical angle determined and the slope measurements properly reduced to true horizontal distances.





FINAL TEST.

Final test was taken on meridian established March 15, 1925, hereinbefore described on page 3.

Young and Sons light mountain transit No. 8389.

April 20, 1925: I examine the adjustments of the transit and find them correct; the to test the solar apparatus by comparing its indications, resulting from observations made during a.m. and p.m. hours with a meridian previously established by Polaris observation, I proceed as follows:

At 8h 0m., a.m., l.m.t., I set off 35°12'N. on the lat. arc, 11°30'N. on the decl. arc and determine a meridian with the solar, which is found to agree with the true meridian.

At apparent noon, with the lat. arc unchanged I observe the sun on the meridian; the resulting reading of the decl. arc is 11°33'N., which agrees with the computed decl. of the sun.

At 4h 0m., p.m., l.m.t., with the lat. arc unchanged, I set off 11°36½'N. on the decl. arc and determine a meridian with the solar, which is found to agree with the true meridian.

As all of the solar observations during the usual hours of solar work come within 1'30" of the true meridian I conclude that the instrument was maintained in satisfactory adjustment throughout the survey of this township.

GENERAL DESCRIPTION

Land is of volcanic formation and consists mainly of rolling topped ridges, divided by abrupt canyons.

There is no rock other than lava, except in the northwest portion of the township, where conglomerate and granite are found at the lower elevations.

The soil is of volcanic origin, generally an adobe formation, though it includes everywhere a large amount of rock, the heavy growth of bunch grass showing at the time of the survey, indicates a possibility of dry farming.

There is a moderately heavy growth of small white and black oak timber on the South half of the township, interspersed with smaller amounts of scrub cedar, juniper and yellow pine. The north half of the township, which includes the San Francisco river and some of its immediate basin, has a sparse growth of the same woods in addition to softer woods along the streams.

Water is scarce in the south half of the township. Live water was seen only in sections 32 and 26. It is plentiful in the north half. The San Francisco river offers possibilities of storage; though it has no feasible dam sites in this township.

Note:

In securing field data for the location of Forest Homestead Survey No. 490, Cor. No. 6 of the original listing survey (which, unfortunately had not been destroyed as reported) was mistaken for Cor. No. 6 of the final survey and tied to the cor. of secs. 2, 3, 10 and 11 of T. 3 S., R. 31 E., as described in location of cor. 6 of

It therefore becomes necessary to segregate H.E.S. No. 490 from its recorded connection to H.E.S. No. 237.
