- Accepted surveys.

Survey commenced March 5, 1925 and executed by William E. Hiester, U.S. Surveyor and Willis W. Bandy, U.S. Surveyor, on dates shown on diagram on page 1 hereof, using respectively Young and Sons transits Nos. 8534 and 8513. Both instruments are equipped with full vertical circle and the Smith solar attachment and were approved by the Assistant Supervisor of Surveys conditional upon satisfactory field tests. Unless otherwise specified all azimuth determinations are accomplished with the solar attachments.

We examine the adjustments of the transits and correct all errors, then to test the solar apparatus by comparing their indications resulting from solar observations made during a.m. and p.m. hourse, with a meridian determined from observation on Polaris, proceed as follows:

March 5, 1925: At camp which is located near the ½ seccor. of secs. 16 and 21, T.34 N., R.7 W., Gila and Salt River Base and Meridian, in latitude 36220'N., longitude 113°2'W. of Greenwich, at 8h 37m p.m., 1.m.t., we observe Polaris at western elongation, making four observations, two each with telescope in direct and reversed positions and mark the mean point in the line thus determined on a peg driven firmly in the ground 5 chs. N.

Azimuth of Polaris at western elongation = 1°21'30".

March 6: At 8h 0m 1.m.t., we lay off the azimuth of Polaris 1°21 to the east and mark a point in the meridian on a stake driven in the ground 5 chs. N.

At 8h 0m a.m., app.t., we set off 36°20'N. on the latitude arcs, 5°39%'S. on the declination arcs and determine meridians with the solars which agree with the true meridian.

At app.noon, with the latitude arcs unchanged, we observe the sun on the meridian, the resulting readings of the declination arcs are 5°36%'S. which agrees with the computed declination of the sun.

At 4h 0m p.m., app.t., with the latitude arcs unchanged, we set off 5°32'S. on the declination arcs and determine meridians with the solars which coincide with the true meridian. From these tests we conclude that the adjustments of the instruments are satisfactory.

Unless otherwise specified all measurements are determined with Lufkin 5-chain steel tapes, compared with a Lufkin standard steel tape and found correct. The measurements are made on the slope, the slope angles determined with clinometers and the slope measurements reduced to true horizontal distances for entry in the field notes.

Final test of solars.

March 26, 1925: At 4 h Om p.m., app.t., On the meridian described above, set off 36°20'N., on the latitude arcs, 2°19½'N. on the declination arcs and describe meridians with the solars which fall within 1' of the true meridian.
