The 2004 California Interagency Wildfire Safety Officer's Workshop will be held on April 27-29, 2004, at Humphrey's Half Moon Inn and Suites, 2303 Shelter Island Drive, in San Diego, California. The workshop will begin promptly at 8:00 A.M. on April 27 and end by 5.00 P.M. on April 29. The workshop is designed for all organizations, and all Wildland Fire Safety Officers, Logistics personnel, and Incident Commanders are specifically invited.
