<u>CUTTING AREA</u>: Eight (8) units totaling approximately ninety-five (95) acres must be partial cut. Five (5) acres of right-of-way must be cut.

<u>ACCESS</u>: Access to the sale area is provided via: United States highways, Government controlled roads, and privately controlled roads.

<u>DIRECTIONS TO SALE AREA</u>: From Roseburg, Oregon travel west on Oregon State Highway 42 approximately 25 miles. Turn right and head north on Signal Tree Road (29-9-36.0). Refer to Exhibits A and A-1 for unit locations.

<u>ROAD USE & MAINTENANCE</u>: Refer to Exhibit E Summary attached. Operator maintenance required on 4.5 miles of road.

DURATION OF CONTRACT: Will be 36 months for cutting and removal of timber. The contract will contain special stipulations regarding logging, road construction, road use and maintenance, fire prevention, hazard reduction and logging residue reduction, log export and substitution, optional scale check of lump sum sales, equal opportunity in employment, cultural resource protection, and sensitive, threatened, or endangered plants or animals.
