<u>LOG EXPORT AND SUBSTITUTION RESTRICTIONS</u>: All timber offered for sale hereunder is restricted from export from the United States in the form of unprocessed timber and is prohibited from being used as a substitute for exported private timber.

<u>CRUISE INFORMATION</u>: With respect to merchantable trees of all species in all cruise strata: the average DBHOB is 11.3 inches: the average gross merchantable log contains 36 bd. ft.; the total gross volume is approximately 10,164 thousand bd. ft.; and 92% recovery is expected. The average DBHOB for Douglas-fir is 10.8 inches; and the average gross merchantable log contains 33 bd. ft. None of the sale volume is salvage material. The following cruise methods were used for volume determination:

<u>VARIABLE PLOT</u>: Timber volumes in the thinning units were based on a variable plot cruise using form class tables for estimating board foot volumes of trees in 16-foot logs. Two hundred forty seven plots were measured using a twenty basal area factor. One hundred sixteen trees were randomly selected to be cruised.

<u>3P</u>: The Douglas-fir and red alder in the hardwood conversion units and the right-of-way have been cruised using the 3P system to select 131 sample trees. The sample trees have been cruised and their volumes computed using form class tables for estimating board foot volumes of trees in 16-foot logs. The volumes are then expanded to a total stratum volume.

<u>100% CRUISE</u>: The grand fir, western hemlock and bigleaf maple timber volumes in the hardwood conversion units and the right-of-way were based on a 100% cruise using form class tables for estimating board foot volume of trees in 16-foot logs.

<u>CUTTING AREA</u>: Nine units totaling approximately 455 acres partial cut, seven units totaling approximately 111 acres hardwood conversion, and 27 acres of right-of-way.

<u>ACCESS</u>: Access to the sale area is provided via: Oregon State highways, Government controlled roads, and privately controlled roads.

<u>DIRECTIONS TO SALE AREA</u>: From Elkton, travel approximately 15 miles west on Highway 38 to Burchard Creek Road No. 22-9-15.1. Refer to Exhibits A and A-1 for unit locations.

<u>DURATION OF CONTRACT</u>: Will be 36 months for cutting and removal of timber.

SPECIAL PROVISIONS:

- 1. Directional felling is required away from roads, property lines, posted boundaries, orange-painted reserve trees, no-harvest areas, and snags.
- 2. A no-harvest zone of a minimum of 20-foot slope distance will be maintained on each side of the stream channels. Corridor trees felled within the no-harvest zone shall be left on site.
- 3. Snags that are felled for safety reasons will be left on site.
- 4. Cutting or yarding during high sap flow, March 31 through July 1, may be restricted by the Authorized Officer.
- 5. Seasonal restrictions will apply in Seasonally Restricted Areas.
- 6. Hauling on dirt roads will be restricted to June 1 through October 15.
- 7. In the Partial Cut Area, trees will be bucked to maximum of 40-foot lengths
- 8. Yarding shall be completed with cable-type equipment capable of lateral yarding 75' each side of the skyline road.
- 9. One-end suspension is required. Lift trees and/or intermediate support trees may be necessary to achieve suspension.
- 10. Full-log suspension required over Stream Channels. Where full suspension cannot be achieved, yarding will occur during the dry season.
- 11. Road building and logging equipment will be washed prior to moving into the Contract Area to minimize the spread of noxious weeds.
- 12. Units 1A, 1C, 1D, 1G, 1H, 1J, 2A, 3A, and 3C require snag creation on a specified number of trees.
- 13. Purchaser may elect to contribute funds in lieu of snag creation.
- 14. Purchaser is not responsible for felling non-merchantable conifers.
- 15. All grand fir, western hemlock, western redcedar, Pacific yew and hardwood trees other than red alder within the Partial Cut Area and Special Cutting Area, except within road right-of-ways, landings, yarding corridors or are needed for safety reasons are reserved from cutting.
