ENVIRONMENTAL ASSESSMENTs were prepared for Blue 25 CT and Lost & Found CT sales, and Findings of No Significant Impact have been documented. A WRITTEN BID on Form 5440-9 at not less than the appraised price on a unit basis per species and the required minimum bid deposit shall be required to participate in oral bidding for each tract.

PRE-AWARD QUALIFICATIONS. The high bidder may be required to furnish information to determine the ability to perform the obligations of the contract. If the high bidder is determined not qualified, responsible or refuses to respond within fifteen (15) days of a request for information pertaining to qualifications, the contract may be offered and awarded for the amount of the high bid to the highest of the bidders who is qualified, responsible, and willing to accept the contract.

LOG EXPORT AND SUBSTITUTION. All timber sales shall be subject to the restrictions relating to the export and substitution of unprocessed timber from the United States in accordance with P.L. 94-165 and 43 CFR 5400 and 5420, as amended. "The BLM has revised the log export restrictions special provision to reduce the log branding and painting requirements. The new requirements include branding of one end of all logs with a scaling diameter of over 10 inches. All loads of 11 logs or more, regardless of the diameter of the logs, will have a minimum of 10 logs branded on one end. All logs will be branded on loads of 10 logs or less. One end of all branded logs will be marked with yellow paint. At the discretion of the Contracting Officer, the Purchaser may be required to brand and paint all logs. The Purchaser shall bear any increased costs for log branding and painting."

VARIABLE PLOT: Timber volumes in Unit 1 were based on a variable plot cruise. Using a 20 basal area factor (BAF), 185 plots were measured; 179 trees were randomly selected to be sampled. The sample trees have been cruised and their volumes computed using form class tables for estimating board foot volumes of trees in 16-foot logs. The volumes are then expanded to a total stratum volume.

3P: The Douglas-fir within the road right-of-way have been cruised using the 3P system to select 156 sample trees. The sample trees have been cruised and their volumes computed using form class tables for estimating board foot volumes of trees in 16-foot logs. The volumes are then expanded to a total sale volume.

100% CRUISE: The western hemlock and red alder timber volumes within the road right-of-way were based on a 100% cruise using form class tables for estimating board foot volume of trees in 16-foot logs.

CUTTING AREA: One unit totaling approximately 160 acres must be partial cut and 6 acres of road right-of-way must be clear cut.

3. Full-log suspension will be required over Stream Channels. Where full suspension cannot be achieved, yarding will occur during the dry season.
4. All snags are reserved from cutting. Snags that are felled for safety reasons will be left on site.
5. Cutting or yarding during high sap flow, March 31 through July 1, may be restricted by the Authorized Officer.
6. Hauling on dirt surfaced roads will be permitted between July 1 and October 15, unless dry conditions extend the hauling season.

The contract will contain special stipulations regarding logging, road construction, road use and maintenance, fire prevention, hazard reduction and logging residue reduction, log export and substitution, optional scale check of lump sum sales, equal opportunity in employment, cultural resource protection, and sensitive, threatened, or endangered plants or animals.

SPECIAL PROVISIONS: This list is not comprehensive. Please review the entire contract.

1. A License Agreement is required with Plum Creek Timberlands, L.P.
2. All equipment must be washed prior to entry into the contract area to control the spread of noxious weeds.
3. The BLM Road Nos. 28-9-12.5 and 28-9-12.5 Ext. are approved for summer haul only. All other roads are approved for wet season haul.
4. A Seasonal Restriction affects parts of Unit 6. Harvest activities are prohibited April 1 through August 5, and a daily timing restriction restricts harvest activities to the period two hours after sunrise to two hours before sunset August 6 through September 15.
5. A Timing Restriction affects parts of Unit 2. Harvest activities are restricted to the period two hours after sunrise to two hours before sunset April 1 through September 15.
6. No trees shall be felled into the Reserve Areas as shown on the Exhibit A. Line pulling, jacking, or other mechanical devices shall be used as necessary.
7. Damage shall affect less than 5% of reserve trees.
8. Lift trees and intermediate support trees may be necessary.
9. One-end suspension required during yarding.
10. Full suspension required when yarding over stream channels.
11. Log lengths shall not exceed 41 feet.
12. Shape and restore all landings to a natural contour to prevent erosion.
13. Seed and fertilize all landings, road cuts and fills, and waste areas.
14. Soil stabilization, water bar construction, road decommissioning, and road barrier construction shall be conducted after the completion of harvest activities but no later than October 15th.
15. BLM will assume supervisory responsibility for disposal of logging slash.
16. Machine and/or hand piling of logging slash are required at all landing areas.
17. After yarding is complete the purchaser shall top 136 conifer trees and fall 204 conifer trees in Units 1-6.
18. This contract contains provisions (Sec. 41.b(11) and Sec. 41.b(12)) for the sale and removal of additional timber necessary to facilitate safe and efficient Purchaser operations. These provisions include:
 - a. The designation and sale of additional timber, such as corridor and guyline trees, at contract price, as necessary to facilitate safe and efficient logging. Such trees may be felled and removed when they are painted by the Authorized Officer;

 - d. The use of unilateral modifications executed by BLM for such additional and replacement timber;
 - e. Revocation of the Purchaser's right to cut additional timber if the Authorized Officer determines that trees have been cut and removed that were not previously marked and approved for cutting and removal by the Authorized Officer; and,
 - f. It is estimated that approximately ten percent of the sale volume (estimated at 227 MBF) of such additional timber may be removed under the contract, but is not included in the advertised sale volume nor was it included in the timber sale appraisal. This estimate is a net figure reduced by the estimate of the volume of trees previously marked for cutting, which the Authorized Officer may elect to reserve.
