No more than 30% of the timber volume from a set-aside sale may be delivered for manufacturing to a business that is not a small business, as defined by the SBA (13 CFR 121.507 (a)).

THIS TIMBER SALE has been cruised based upon Eastside Scribner board foot measure. The volumes herein are estimates only, based on 16-foot taper breaks, which must be taken into consideration if comparisons are made with volume predictions based on other standards. The volumes based on 32-foot taper breaks are shown for comparison purposes. No sale shall be made for less than the total purchase price, without regard to the amount bid per unit, even though quantity of timber actually cut or removed or designated for taking is more or less than the estimated volume or quantity so listed.

<u>CRUISE INFORMATION</u>: With respect to merchantable trees of all species in all cruise strata: the average DBHOB is 14.6 inches: the average gross merchantable log contains 59 bd. ft.; the total gross volume is approximately 3,580 thousand bd. ft.; and 86 % recovery is expected. The average DBHOB for Douglas-fir is 16.6 inches; and the average gross merchantable log contains 73 bd. ft. None of the total sale volume is salvage material. The following cruise method was used for volume determination:

<u>VARIABLE PLOT</u>: Timber volumes in Units 1 & 2 were based on a variable plot cruise. Using a 40 basal area factor (BAF), 250 plots were measured and 183 trees were randomly selected to be sampled. The sample trees have been cruised and their volumes computed using form class tables for estimating board foot volumes of trees in 16-foot logs. The volumes are then expanded to a total sale volume.

<u>3P CRUISE</u>: The timber volumes within the road right-of-way and hazard tree areas were based on 3P cruise data using form class tables for estimating board foot volume of trees in 16-foot logs and 22 trees were randomly selected to be sampled.

<u>CUTTING AREA</u>: Two units totaling approximately 128 acres must be partial cut. Three acres of right-of-way must be

cut. Acres shown on Exhibit A have been computed using a Trimble Geo 7X Global Positioning System receiver. Acreage was calculated based on Global Positioning System traverse procedures including differential correction.

<u>ACCESS</u>: Access to the sale area is provided via: Oregon State highways, Coos County roads, privately controlled roads, and Government controlled roads.

<u>DIRECTIONS TO SALE AREA</u>: From Hwy 42 traveling east towards Coquille, OR, turn left onto W. The contract will contain special stipulations regarding logging, road construction, road use and maintenance, fire prevention, hazard reduction and logging residue reduction, log export and substitution, optional scale check of lump sum sales, equal opportunity in employment, cultural resource protection, and sensitive, threatened, or endangered plants or animals.

#### SPECIAL PROVISIONS: This list is not comprehensive. Please review the entire contract.

- 1. License agreements are required with New Growth Olympus LLC, a performance bond in the amount of \$10,000 and comprehensive liability insurance will be required for this license agreement. A license agreement is required with Weyerhaeuser Corporation, a performance bond in the amount of \$10,000 and comprehensive liability insurance will be required for this license agreement.
- 2. The Purchaser shall notify the Bonneville Power Administration (BPA) at least 30 days prior to the start of operations within or adjacent to the BPA Transmission Line R/W or within the BPA Hazard Tree Area. The purchaser must meet with a representative from BPA. The current contact for the BPA is Andy Crosby, phone no. (541) 297-8496.
- 3. All equipment must be washed prior to entering and exiting the contract area to control the spread of noxious weeds and Port-Orford-cedar root disease.
- 4. A Seasonal Restriction affects portions of Units 1 & 2. Tree felling, yarding, and road construction operations are prohibited from March 1 through August 5. Additionally, a daily timing restriction confines tree felling, yarding, and road construction operations to the period from two hours after sunrise to two hours before sunset from August 6 through September 15.
- 5. All roads are summer haul only (June 1 through October 15).
- 6. No trees shall be felled into the Reserve Area, shown on the Exhibit A. Line pulling, jacking, or other mechanical devices shall be used as necessary.
- 7. Damage shall affect less than 5% of reservetrees.
- 8. Lift trees and intermediate support trees may be necessary.
- 9. One-end suspension required in cable and ground-based yarding areas.
- 10. Full suspension required over any stream channels. Trees cut for yarding corridors within the Reserve Area adjacent to Stream Channels shall be felled toward the channel and left on site.
- 11. Yarding corridors and skid trails shall be placed to avoid cutting reserve trees greater than or equal to 24" DBH within 220' of a Stream Channel. If a reserve tree greater than or equal to 24" DBH is cut for a yarding corridor or skid trail within 220' of a Stream Channel, the tree shall be left on site and will counted towards the required post-harvest down wood creation requirements.
- 12. A forwarder, log loader, tractor, or rubber tire skidder may be used to yard logs within the ground-based yarding areas. Ground-based equipment shall not operate within fifty feet of any Stream Channel and are restricted to areas with slopes less than 35%.
- 13. Log lengths shall not exceed 41 feet.
- 14. Purchaser shall verify all landing locations and stake required clearing limits prior to construction.
- 15. Shape and restore all landings to a natural contour to preventerosion.
- 16. Seed and fertilize all landings, road cuts and fills, and wasteareas.
- 17. Soil stabilization, water bar construction, road decommissioning, and road barrier construction shall be conducted after the completion of harvest activities but no later than October 15<sup>th</sup>.

shall include one (1) person qualified at a minimum, as Type-I Firefighter (FFT1) and four (4) Type-II Firefighters, (National Wildfire Coordinating Group (NWCG) Wildland Fire Qualifications System guide, PMS 310-1).

- 21. Hazardous Fuel Reduction Areas are located in Unit 1 and Unit 2.
- 22. After yarding is complete the purchaser shall girdle 168 conifer trees and fall 112 conifer trees in Unit 1 and girdle 24 conifer trees in Unit 2.
- 23. Purchaser shall obtain a permit from the Coos County Department of Roads, prior to operations on Sitkum Lane County Road and shall keep the Sitkum Lane County Road where it passes through the contract area open and free of debris.
- 24. The Purchaser shall provide signage and flaggers to control traffic when conducting operations adjacent to any road.
- 25. This contract contains provisions (Sec. 42.b(11) and Sec. 42.b(12)) for the sale and removal of additional timber necessary to facilitate safe and efficient Purchaser operations. These provisions include:
