CATEGORICAL EXCLUSION REVIEW

**West Eugene Wetlands Parking Area
Maintenance/Improvement
CE-03-31**

Background

The West Eugene Wetland Office site is experiencing greater and greater use. As such the parking area needs to be improved to accommodate more vehicles and provide for an all weather surface.

Montia howellii, a BLM tracking species, is known to occur in the parking lot, particularly the portion of the lot where the project disturbance would occur. Presence of this annual species seems to be enhanced by mild disturbance activities such a vehicle passage, parking, and occasional grading of the parking lot. This species is an annual and has already gone to seed for the year. Stockpiling and redistribution of the surface material after the lot is graveled is a viable means of insuring the persistence of the species.

Proposed Action

The proposed action is to distribute additional gravel across the existing parking surface. Prior to this however, the first several inches of surface material where the Montia howellii population has been identified and the seed located, will be stockpiled. Gravel will be spread across the project area, graded and compacted. At this point the stockpiled surface material would then be redistributed across its previous extent. Particular attention will be paid to the preservation of topological depressions which contain adequate fine materials, which the species depends on. On-site botanical expertise will insure that this action will be executed with the intent of preserving the species.

Decision

It is my decision to approve the Proposed Action and to instruct the Road Maintenance Crew to work in conjunction with the on-site botanist/specialist to accomplish this work.

Rationale

The Proposed Action qualifies as a categorical exclusion as described in Departmental Categorical Exclusions (516 DM 2, Appendix 1) (1.7) "Routine and continuing government business, including such things as ... maintenance and replacement activities having limited context and intensity, e.g., limited size and magnitude or short term effects. The proposed action does not meet any of the exception criteria and therefore an Environmental Assessment (EA) is not necessary.
