LOCATION/LLEGAL DESCRIPTION: The general project area is located in Eugene Districts' Upper Willamette Resource Area T. 17 S., R. 1 W., Section 32, and T. 18 S., R. 1 W., Section 5, using Road No. 17-1W-32.

APPLICANT (if any): Della Webb

A. Description of Proposed Action and any applicable mitigation measures

The Proposed action is to issue an O. and C. Logging Road Right-of-Way Permit E-1012 to Della Webb for a period not to exceed three years from the issuance, pursuant to the authority of Title V of the Federal Land Policy and Management Act of 1976 (43 U.S.C. 1761), subject to the terms and conditions in 43 CFR 2812 and those additional stipulations in the attached draft permit. The permit would authorize the hauling of approximately 40 MBF of timber over 0.12 miles of BLM controlled Road No. 17-1W-32. BLM will maintain Road No. 17-1W-32.

B. Land Use Plan (LUP) Conformance

LUP Name: Eugene District Record of Decision and Resource Management Plan (RMP), as amended. Date Approved: June 1995.

This project is in conformance the 1995 Record of Decision for the Amendments to Forest Service and Bureau of Land Management Planning Documents within the Range of the Northern Spotted Owl (Northwest Forest Plan (NSO-ROD) USDA Forest Service and USDI Bureau of Land Management, April 1994), and the 1995 Eugene District Resource Management Plan (1995 RMP) including the 2007 Record of Decision to Remove the Survey and Manage Mitigation Standards and Guidelines from Bureau of Land Management Resource Management Plans within the Range of the Northern Spotted Owl.

The proposed action is in conformance with the LUP, even though it is not specifically provided for, because it is clearly consistent with the following LUP decisions:

Rights-of-Way, p. 95

"Continue to make BLM administered lands available for needed rights-of-way where consistent with local comprehensive plans, Oregon Statewide planning goals and rules, and the exclusion and avoidance areas identified in this RMP."

C. Compliance with NEPA

The Proposed Action is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with 516 DM 11.9 (E)(16): Acquisition of easements for an existing road or issuance of leases, permits, or rights-of-way for the use of existing facilities, improvements, or sites for the same or similar purposes.

This categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. The proposed action has been reviewed, and none of the extraordinary circumstances described in 516 DM 2 apply

Decision

If a notice of appeal does not include a statement of reasons, such statement must be filed with this office and with the Board within 30 days after the notice of appeal was filed. A copy of a notice of appeal and any statement of reasons, written arguments, or briefs, must also be served upon the Regional Solicitor, Pacific Northwest Region, U.S. Department of the Interior, 805 SW Broadway, Suite 600, Portland, OR 97205.


