A. Background

Description of Proposed Action:

The proposed action is the transfer of the Section 15 livestock grazing lease for the Two Mile Allotment (#00806). The grazing preference is being transferred from the current base property owned the by Lost River Ranch to base property owned by Steven K. and Deeanna Gorden. The grazing lease will be transferred to Steven K. Gorden in accordance with 43 CFR §4110.2-3.

The transferred grazing lease will have the same parameters as the current lease, as follows:


