

## BLM to Release Cascade-Siskiyou National Monument Livestock Impacts Studies

**January 24, 2008** – The Bureau of Land Management (BLM) Medford District today announced that is has completed the studies of livestock impacts for the Cascade-Siskiyou National Monument (CSNM) and is releasing them to the public.

The 2000 CSNM Presidential Proclamation directed the Secretary of the Interior to "...study the impacts of livestock grazing on the objects of biological interest in the monument with specific attention to sustaining the natural ecosystem dynamics." The original projects defined by the *Plan for Studying the Impacts of Livestock Grazing on the Objects of Biological Interest* released in November 2005 are summarized into nine papers.

In the spring of 2008, the findings from the Livestock Impacts Studies, and all other available data, will be used in an evaluation to determine whether or not the allotments are meeting BLM's Oregon/Washington Standards for Rangeland Health. This information will also be used to determine if livestock grazing is consistent with the 2000 Presidential Proclamation.

A final decision will be issued at the end of 2008 which could maintain, modify, or cancel (retire) the existing grazing lease authorizations. At this point in time there is no formal public comment period. In the future the public will have several opportunities to be involved in the planning processes associated with the grazing within CSNM.

Awaiting the findings of the Livestock Impacts Studies and the final grazing decision, the BLM has continued to manage existing grazing allotments within the monument. Currently, eleven ranchers hold grazing leases for 2,714 active animal unit months within CSNM. An animal unit month represents the amount of forage required to support an "animal unit," or one mature 1000 pound cow and her calf, for one month.
