Location: The haul route and affected road is located on BLM administered lands in the Upper Jenny Creek area in T. 39 S., R. 4 E., in Sections 3, 8, 9 & 10. T. 38 S., R. 4 E., in Sections 19, 29, 32 & 33. T. 38 S., R. 3 E., in Section 13 W.M., Jackson County, Oregon (Exhibit A).

DESCRIPTION OF THE PROPOSED ACTION:

The Ashland Resource Area of the Medford District BLM proposes to issue an O&C Logging Road Right-of-Way Permit to a private land owner, under the provisions of 43 CFR Subpart 2812, and P.L. 94-579; 90 Stat 2743. This has been designated as Permit No.M-5060 (OR 067365). The requested period of use is for 5 months, with the possibility of one-month extensions at the discretion of the Authorized Officer. The permit will allow commercial hauling of approximately 500 MBF of private timber over an existing BLM road. Utilization of this road would, by itself, not facilitate any ground-disturbing actions on federal lands. The permit would not be a determining factor as to whether ground-disturbing actions would occur on private lands.

The following table identifies the BLM roads to be used, estimated timber volumes to be hauled over each road and the anticipated haul periods:

The Permittee agrees to comply with the following environmental and safety stipulations as required project design features:

- The Permittee shall discontinue hauling under this permit upon written notice of the Authorized Officer that such operations are causing damage to the existing facilities.
- Use of the road under this permit is limited to Dry Weather Use generally from May 15 to October 15. This restriction could be waived by the authorized officer, in consultation with a watershed specialist, under dry conditions.
- Permittee shall leave the road in as good of condition than what existed prior to use. When maintaining inboard ditches, avoid blading and vegetation removal unless absolutely necessary. All soil disturbance associated with road drainage improvement shall be within the existing road Rights-of-Way. All ground disturbances within riparian reserves shall be mulched with weed free straw or native materials. A minimum of 80 percent ground cover shall be maintained following such activities. Where the potential for surface erosion is high, consider seeding with native grass seed. Retain ground vegetation on cut and fill slopes in order to reduce surface erosion and maintain slope stability unless it poses a safety hazard or restricts maintenance activities. Where roadside vegetation removal is necessary, preferably cut roadside vegetation rather than pulling it out and disturbing the soil. Avoid blading and vegetation removal unless necessary to remove drainage impediments when maintaining inboard ditches. Control sediment by spreading weed-free straw in ditchlines where ditchline blading is required within 100 feet of streams. Avoid undercutting the toe of cutslopes and sidecasting. Sidecasting of material shall not occur within 200 feet of streams.
- The Permittee agrees to comply with the following environmental and safety stipulations as required project design features. The Permittee shall discontinue hauling under this permit upon written notice of the Authorized Officer that such operations are causing damage to the existing facilities. This restriction could be waived by the authorized officer, in consultation with a watershed specialist, under dry conditions. All equipment will be washed prior to entering BLM lands to avoid the introduction of noxious weeds.
- Hauling would not commence before July 1 in accordance with the northern spotted owl nesting protocol.

Wildlife:

- Since there is no ground disturbance proposed, and, the existing road prism is not suitable habitat for any special status wildlife, there will be no effect to federally-listed, survey and manage or bureau special status wildlife.
- The northern spotted owl, a threatened species, is the only federally listed or proposed threatened/endangered wildlife species with suitable habitat in the vicinity of the proposed operations. None of the operations proposed on Federal land would modify northern spotted owl suitable habitat.
- Issuing the Land Use Permit would not adversely affect wildlife species that are listed or proposed for listing under the auspices of the Endangered Species Act of 1973, as amended.

Hydrology

- Restrict road maintenance and log hauling activities to the dry months (May 15-October 15). Avoid extending the permit beyond these dates.
- When maintaining inboard ditches, avoid blading and vegetation removal unless absolutely necessary.
- All soil disturbance associated with road drainage improvement shall be within the existing road Rights-of-Way
- All ground disturbance within riparian reserves shall be mulched with weed free straw or native materials. A minimum of 80 percent ground cover shall be maintained following such activities. Where the potential for surface erosion is high, consider seeding with native grass seed.

- Retain ground vegetation on cut and fill slopes in order to reduce surface erosion and maintain slope stability unless it poses a safety hazard or restricts maintenance activities. Where roadside vegetation removal is necessary, preferably cut roadside vegetation rather than pulling it out and disturbing the soil.
- Avoid blading and vegetation removal unless necessary to remove drainage impediments when maintaining inboard ditches. Control sediment by spreading weed free straw in ditchlines where ditchline blading is required within 100 feet of streams.
- Avoid undercutting the toe of cutslopes and sidecasting. Sidecasting of material shall not occur within 200 feet of streams.

PLAN CONFORMANCE

The proposed action is in compliance with the *1995 Medford District Record of Decision and Resource Management Plan (RMP)* which states to “continue to make BLM-administered lands available for needed rights-of-way.” The 1995 Medford District Resource Management Plan incorporated the *Record of Decision for Amendments to Forest Service and Bureau of Land Management Planning Documents Within the Range of the Northern Spotted Owl and the Standards and Guidelines for Management of Habitat for Late-Successional and Old-Growth Forest Related Species Within the Range of the Northern Spotted Owl (Northwest Forest Plan)* (USDA and USDI 1994). The 1995 Medford District Resource Management Plan was later amended by the 2001 *Record of Decision and Standards and Guidelines for Amendments to the Survey and Manage, Protection Buffer, and other Mitigation Measures Standards and Guidelines*.

This proposed action is also consistent with the 2001 Record of Decision and Standards and Guidelines for Amendments to the Survey and Manage, Protection Buffer, and other Mitigation Measures Standards and Guidelines (2001 ROD), as modified by the 2011 Settlement Agreement. This project is not a habitat disturbing activity, as defined in page 22 of the Standards and Guidelines of the *2001 Record of Decision and Standards and Guidelines*, for any Survey and Manage species. Because the project is not habitat disturbing, the Survey and Manage provisions, including pre-disturbance surveys, are not required (Standards and Guidelines, p. 7, 21-22).

The proposed action is also in conformance with the direction given for the management of public lands in the Medford District by the Oregon and California Lands Act of 1937 (O&C Act), Federal Land Policy and Management Act of 1976 (FLPMA), the Endangered Species Act (ESA) of 1973, the Clean Water Act of 1987, Safe Drinking Water Act of 1974 (as amended 1986 and 1996), Clean Air Act, and the Archaeological Resources Protection Act of 1979.

CATEGORICAL EXCLUSION REVIEW

COMPLIANCE WITH NEPA

In accordance with 43 CFR §§ 46.205(c) and 46.215, the proposed action has been reviewed against the twelve criteria above and I have determined that none of the extraordinary circumstances described in 43 CFR § 46.205(c) apply to this project. The project qualifies as a categorical exclusion under 516 DM 11.9 E (16) which allows for the “*issuance of leases, permits, or rights-of way for the use of existing facilities, improvements, or sites for the same or similar purposes.*”


DECISION
