### DESCRIPTION & LOCATION OF THE PROPOSED ACTION

The proposed action is to renew a right-of-way (ROW) grant for existing spring developments, buried water pipeline, and storage tanks. ROW grant OR 24498 was issued in 1984, and renewed in 1993 and 2004. ROW grant 37836 was issued in 1987, and renewed in 1994 and 2004. One spring development is 45' x 10' and contains 0.01 acres; the other is 40' x 40' for spring development and 10' x 607' for the buried water line and contains 0.17 acres. The applicant is requesting a 30-year term. The applicant also wishes to combine the two grants and only have one ROW issued that covers both improvements. The location of the improvements is:

SE1/4 NE1/4 SW1/4, NW1/4 SE1/4 Section 25  
Township 39 South, Range 3 East,  
Willamette Meridian, Jackson County, Oregon

### PLAN CONFORMANCE

The proposed action is located on BLM-administered land in the Cascade-Siskiyou National Monument. It is in conformance with and tiered to the 2008 *Cascade-Siskiyou National Monument ROD and RMP*. The proposed action is in conformance with the direction given for the management of public lands in the Medford District by the Oregon and California Lands Act of 1937 (O&C Act), Federal Land Policy and Management Act of 1976 (FLPMA), the Endangered Species Act (ESA) of 1973, the Clean Water Act of 1987, Safe Drinking Water Act of 1974 (as amended 1986 and 1996), Clean Air Act, and the Archaeological Resources Protection Act of 1979.


