Our practice is to make comments, including the names and addresses of respondents, available for public review. Unless you specifically request us to withhold your name and address, it will be made available to the public on request.

The review of the environmental effects of a proposed management action can occur in one of four ways: categorical exclusion (CX), determination of National Environmental Policy Act (NEPA) adequacy (DNA), environmental assessment (EA), or environmental impact statement (EIS). The list below includes only EA and EIS. See the Prineville District's web page for CX (covering actions that are excluded from NEPA analysis) and DNA (actions that are already covered by existing analysis).

The decision follows public review by 30 days or more; implementation begins immediately after decision, unless there is an appeal period (varies by program).
