# TIMBER SALE NOTICE

NOTICE IS HEREBY GIVEN that the Bureau of Land Management will offer for sale timber as described herein for oral auction, pursuant to Instructions to Bidders, as stated on Form No. 5440-9, attached. Written and oral bids will be received by the District Manager, or designated representative, at 777 NW Garden Valley Blvd., Roseburg, Oregon 97471. The timber sale will commence at 10:00 a.m., on Tuesday, October 24, 2017.

AN ENVIRONMENTAL ASSESSMENT was prepared for this sale, and a Finding of No Significant Impact has been documented. These documents are available for inspection as background for this sale at the Roseburg District Office.

THIS TIMBER SALE NOTICE does <u>not</u> constitute the decision document for purposes of protest and appeal of a forest management decision. Consistent with 43 CFR Subpart 5003-Administrative Remedies, the notice of a timber sale, when published as a legal ad in a newspaper of general circulation, shall constitute the decision document for purposes of protest and appeal.

Protests may be filed with the Contracting Officer within 15 days after the first publication of the aforementioned decision document in the newspaper. It is anticipated that the decision document will be published in *The News Review* newspaper on or about September 26, 2017. BLM does not warrant publication on this exact date. All parties considering protest of the timber sale decision document are encouraged to review the aforementioned newspaper to ensure accurate knowledge of the exact publication date.

A WRITTEN BID on Form No. 5440-9 at no less than the appraised price on a unit basis per species and the required minimum bid deposit shall be required to participate in oral bidding for each tract. Oral bidding will be restricted to Douglas-fir.

THE SUCCESSFUL BIDDER, as a condition of award, will be required to complete and/or sign the following forms:

1. Form No. 5450-17, Export Determination. PRE-AWARD QUALIFICATIONS. The high bidder may be required to furnish information to determine the ability to perform the obligations of the contract. If the high bidder is determined not qualified, responsible or refuses to respond within fifteen (15) days of a request for information pertaining to qualifications, the contract may be offered and awarded for the amount of the high bid to the highest of the bidders who is qualified, responsible, and willing to accept the contract.

A PERFORMANCE BOND in an amount not less than twenty (20) percent of the total purchase price will be required for all contracts of \$2,500 or more, but the amount of the bond shall not be in excess of \$500,000, except when the Purchaser opts to increase the minimum bond as provided in 43 CFR 5451.2. A minimum performance bond of not less than \$500 will be required for all installment contracts less than \$2,500.

"LOG EXPORT AND SUBSTITUTION: All timber sales, including timber from Federal rights-of-ways, shall be subject to the restrictions relating to the export and substitution of unprocessed timber from the United States in accordance with P.L. 94-165 and 43 CFR 5400 and 5424 as amended."

"LOG EXPORT AND SUBSTITUTION RESTRICTIONS: Excepting Port-Orford-cedar, all timber offered for sale hereunder is restricted from export from the United States in the form of unprocessed timber and is prohibited from being used as a substitute for exported private timber."

<u>THE VOLUMES LISTED</u> herein are estimates only, based on 16-foot taper breaks, which must be taken into consideration if comparisons are made with volume predictions based on other standards. The volumes based on 32-foot taper breaks are shown for comparison purposes. No sale shall be made for less than the total purchase price, without regard to the amount bid per unit, even though quantity of timber actually cut or removed or designated for taking is more or less than the estimated volume or quantity so listed.

<u>APPRAISED PRICES</u> are determined by analytical appraisal methods unless otherwise noted on individual timber sale notices.

## LOG EXPORT AND SUBSTITUTION RESTRICTIONS:

All timber sales, including timber from Federal rights-of-way, shall be subject to the restrictions relating to the export and substitution of unprocessed timber from the United States in accordance with P.L. 94-165 and 43 CFR 5400 and 5424 as amended.

Excepting Port-Orford-cedar, all timber offered for sale hereunder is restricted from export from the United States in the form of unprocessed timber and is prohibited from being used as a substitute for exported private timber.

## **CRUISE INFORMATION:**

For Harvest Area 1: The Douglas-fir, Incense-cedar, and Ponderosa Pine have been cruised using the 3P system to select sample trees. For Harvest Area 2 and 3: The Douglas-fir and Incense-cedar up to 48 inches D.B.H.O.B. have been cruised using the 3P system to select sample trees. The sample trees have been cruised and their volume computed on form class tables for estimating volume in 16-foot lengths. This volume is then expanded to a total sale volume. A map showing the location of these sample trees is available at the Roseburg District Office. The volume of Grand Fir in Harvest Area 1 and the volume of the Grand Fir and Western Hemlock in Harvest Areas 2 and 3 have been determined by individual tree measurements using a 100% cruise.

With respect to merchantable trees of all species in Harvest Area 1: the average tree is 17.5 inches D.B.H.O.B., the average log contains 79 bd. ft., the total gross volume is approximately 7,418 MBF and 77% recovery is expected.

With respect to merchantable trees of all species in Harvest Areas 2 and 3: the average tree is 13.6 inches D.B.H.O.B., the average log contains 50 bd. ft., the total gross volume is approximately 1,277 MBF and 88% recovery is expected.

<u>CUTTING AREA</u>: An area of approximately 151 acres in 1 unit will be regeneration harvested, 112 acres in 3 units will be thinned, and 2 acres of road right-of-way will be clear cut.

<u>ACCESS</u>: Access to the sale area is provided by Government, County, and privately controlled roads. A road use fee of \$566.40 will be required to be paid to Roseburg Resources Co. A road use fee of \$1829.10 will be required to be paid to Silver Butte Timber Company.

### DIRECTIONS TO SALE AREA:

From Roseburg, proceed South on I-5 approximately 26.4 miles to Exit 98 Canyonville. Then:

Harvest Area 1 and 2: proceed East on Douglas Co Road 1 (Tiller Trail Hwy) approximately 8.4 miles, turn left onto County Road 34 (Days Creek Rd) for approximately 1.6 miles, turn left onto County Road 92 (Woods Creed Rd) for 0.35 miles, then turn left on Road 30-4-3.1. Refer to timber sale Exhibits A and D for further details to Contract Area.

Harvest Area 3: proceed East on Douglas Co Road 1 (Tiller Trail Hwy) approximately 8.4 miles, turn left onto County Road 34 (Days Creek Rd) for approximately 2.8 miles, then turn right onto Road 30-4-1.0 (Bland Mtn. Road) and follow the Exhibit D map approximately 2.84 miles to the Contract Area.

<u>ROAD MAINTENANCE</u>: Rockwear and maintenance fees of \$9,291.09 will be required to be paid to the BLM; and rockwear and maintenance fees of \$756.68 will be required to be paid to Silver Butte Timber Co.

<u>ROAD CONSTRUCTION</u>: Estimates include the following: construct 32+50, renovate 470+60 stations, and decommission 7+70 stations of road. Additional information is available in Exhibit C and Exhibit D of the Timber Sale Contract.

<u>DURATION OF CONTRACT</u> will be 36 months for cutting and removal of timber. The contract contains SPECIAL PROVISIONS regarding: logging; road construction, renovation, maintenance, and use; environmental protection; fire prevention; slash disposal; safety; and log exports. Log scaling may be required under the terms of this contract.

# NOTES:

1. A revised Special Provision has been added to the contract which enables the Contracting Officer to suspend the contract to facilitate protection of certain plant or animal species, and /or to modify or terminate the contract when necessary to: (1) Comply with the Endangered Species Act or to prevent incidental take of northern spotted owls in accordance with the management direction in the Record of Decision (ROD) and Resource Management Plan (RMP), or; (2) Comply with a court order, or; (3) Protect species which were identified for protection through survey and manage and/or protection buffer standards and guidelines established in the ROD and RMP.

This contract provision limits the liability of the Government to the actual costs incurred by the Purchaser which have not been amortized by timber removed from the Contract Area.

- 2. Seasonal restrictions on operations apply to this sale regarding road work, falling, bucking, yarding, loading, hauling, sub-soiling, machine piling and burning, and wildlife nesting seasons. Refer to Sections 42(A)(3-5), 42(A)(8)(b), 42(A)(9)(b), 42(B)(2), 42(C)(3)(c), 42(C)(4)(d), and Exhibit F for details. A Seasonal Restriction Matrix is included with this prospectus to serve as a guide in planning and scheduling operations for each Harvest Area.
- License agreements with SILVER BUTTE TIMBER CO. and ROSEBURG RESOURCES CO. are required. The terms and conditions of the license agreement are available for inspection at the Roseburg District Office.
- 4. This contract contains provisions for the sale and removal of additional timber necessary to facilitate safe and efficient Purchaser operations. It is estimated that approximately 341 MBF of such additional timber would be removed under the contract, but is not included in the advertised sale volume.
- 5. Slash disposal requirements consist of the following: machine piling, covering and burning slash and debris within a fifty foot radius of landings (approximately 150 landings); and hand piling, covering and burning slash and debris within fifty feet either side of designated roads in Harvest Areas 1 and 3 (approximately 16 acres). The Purchaser will have the option to assist in burning or to make a contribution to the Bureau of Land Management in lieu thereof. Refer to Section 42(F), Section 42(G) and Exhibit E for details.
- 6. Purchaser shall, upon completion of logging operations, perform subsoiling operations on approximately nineteen hundredths (0.19) miles of landings, and main skid trails, and associated compacted areas such as turnouts, truck turnarounds and log decking areas as designated by the Authorized Officer. Refer to Section 42(C)(4).
- 7. In Harvest Area 1, reserve trees are marked in old orange and fresh orange paint. Larger trees are painted with 4 dots, and smaller trees are painted with a band above stump height. In Harvest Areas 2 and 3, reserve trees are painted in yellow, and the old orange paint is to be disregarded in Harvest Areas 2 and 3.
- 8. Purchaser is required to purchase timber from Thomas Clay Michaels at the appraised price of \$2,299.91 for timber associated with easement. Refer to section 42(B)(10).

### INSTRUCTIONS TO BIDDERS

1. AUTHORITY — Timber located on the revested Oregon and California Railroad Grant Lands and on the reconveyed Coos Bay Wagon Road Grant Lands is administered and sold pursuant to authority of the Act of August 28, 1937 (50 Stat. 874; 43 U.S.C. 1181a); timber located on other lands and other vegetative resources on all public lands of the United States under jurisdiction of the Bureau of Land Management are administered and sold pursuant to authority of the Act of July 31, 1947 (61 Stat. 681), as amended, by the Act of July 23, 1955 (69 Stat. 367; 30 U.S.C. 601 et. seq.). Regulations of the Secretary of the Interior governing sale of timber are codified in 43 CFR Group 5400.

2. QUALIFICATIONS OF BIDDERS — A bidder for sale of timber/vegetative resources must be either (a) a citizen of the United States, (b) a partnership composed wholly of such citizens, (c) an unincorporated association composed wholly of such citizens, or (d) a corporation authorized to transact business in the State in which the timber/vegetative resource is located.

3. INSPECTION OF TIMBER/VEGETATIVE RESOURCES — Bidder is invited, urged, and cautioned to inspect the timber/vegetative resource prior to submitting a bid. By executing the timber/vegetative resource sale contract, bidder warrants that the contract is accepted on the basis of his examination and inspection of the timber/vegetative resource and his opinion of its value.

4. DISCLAIMER OF WARRANTY — Government expressly disclaims any warranty of the fitness of the designated timber/vegetative resource for any purpose of the bidder; all timber/vegetative resources are to be sold "As Is" without any warranty of merchantability by Government. Any warranty as to the quantity or quality of timber/vegetative resource to be sold is expressly disclaimed by Government.

5. *BIDS* — Sealed or written bids for not less than the advertised appraised price, per timber/vegetative resource must be submitted in duplicate to the District Manager who issued *Timber/Vegetative Resource Sale Notice*.

(a) Sealed Bid Sales — Bids will be received until time for opening which is set out in the Notice. Enclose both copies of bid with required bid deposit in a sealed envelope marked on the outside Bid for Timber/Vegetative Resource, time bid is to be opened, tract number, and legal description of land on which timber/vegetative resource is located. In event of a tie, the high bidder shall be determined by lot from among those who submitted the tie bids.

(b) Auction Sales — Submission of the required bid desposit and a written bid is required to qualify for oral bidding. Oral bidding shall begin from the highest written bid. No oral bid will be considered which is not higher than the preceding bid. In the event there is a tie in high written bids, and no oral bidding occurs, the bidder who was the first to submit his bid deposit and written bid shall be declared the high bidder. If the officer conducting the sale cannot determine who made the first submission of high tie written bids, the high bidder shall be determined by lot. High bidder must confirm his bid, in writing, immediately upon being declared high bidder.

(c) Except as otherwise provided in 43 CFR 5442.2, bids will not be considered in resale of timber/vegetative resource remaining from an uncompleted contract from any person or affiliate of such person who failed to complete the original contract because of (1) cancellation for the purchaser's breach or (2) through failure to complete payment by expiration date.

(d) When it is in the interest of the Government to do so, it may reject any and all bids and may waive minor deficiencies in bids or in sale advertisement.

6. BID FORMS — All sealed, written bids, and confirmation of oral bids shall be submitted on forms provided by Government.

(a) Lump Sum Sales — Bids shall specify (1) Bureau of Land Management estimated volume, (2) price per unit, and (3) total purchase price. Estimated volume and price per unit are to be used for administrative and appraisal purposes only. Upon award of contract, high bidder shall be liable for total purchase price, including any adjustment which may be made as a result of reappraisal if an extension of time is granted, even though quantity of timber/vegetative resource actually cut, removed, or designated for taking is more or less than the estimated volume or quantity listed.

(b) *Timber Scale Sales* — Bids must state price per thousand board feet that will be paid for each species. High bidder will be determined by multiplying bid price per thousand board feet per species by Bureau of Land Management estimate of volume of each species. Purchaser shall be liable for purchase price of all merchantable timber sold under contract even though all such timber is not actually cut and removed prior to expiration of time for cutting and removal as specified in contract.\*

7. BID DEPOSIT — All bidders must make a deposit of not less than the amount specified in the *Timber/Vegetative Resource Notice*. Deposit may be in the form of cash, money orders, bank drafts, cashiers or certified checks made payable to the Department of the Interior—BLM, bid bonds of a corporate surety shown on the approved list of the United States Treasury Department\*, or any approved guaranteed remittance approved by the Authorized Officer. Upon conclusion of bidding, the bid deposit of all bidders, except high bidder, will be returned. The cash deposit of the successful bidder may be applied toward the required sale deposit and/or the purchase price. Cash not applied to the sale deposit or the purchase price, or a corporate surety bid bond, will be returned at the time the contract is signed by the Government.

8. AWARD OF CONTRACT — Government may require high bidder to furnish such information as is necessary to determine the ability of bidder to perform the obligation of contract. Contract will be awarded to high bidder, unless he is not qualified or responsible or unless all bids are rejected.
