DESCRIPTION OF THE PROPOSED ACTION: Boise Cascade submitted an application (SF-299) requesting the use of an existing road in order to haul an estimated 80 truckloads of logs (450 MBF) from a timber sale on Forest Service land. No hauling would be allowed when the road was wet and damage to the road could occur. Boise Cascade would perform general maintenance and grading activities on road to prepare for hauling timber and as necessary to return road to pre-haul conditions.

The ROW would expire on December 31, 2016.

PLAN CONFORMANCE

All actions approved or authorized by the BLM must conform to the existing land use plan where one exists (43 CFR 1610.5-3, 516 DM 11.9). Although it is not a NEPA requirement, the BLM includes within all its NEPA documents a statement about the conformance of the proposed action and alternatives with the existing land use plan. The BLM's planning regulations state that the term "conformity" or "conformance" means that "... a resource management action shall be specifically provided for in the plan, or if not specifically mentioned, shall be clearly consistent with the terms, conditions, and decisions of the approved plan or amendment" (43 CFR 1601.0-5(b)).

The proposed action is in conformance with the program-specific direction for realty management of the Baker Resource Management Plan (RMP), cited on page 23 of the RMP. Exclusion areas are: wilderness areas and wild river segments. The proposed use is not within an exclusion area. Avoidance areas are Wilderness study area, ACECs, and scenic and recreation river segments. The road is within the Oregon Trail ACEC and stipulations will be included in the ^{of} to protect the resources for which the ACEC was designated.


