## Reading a Plat

The land status records are designed to portray the title story by use of lines and notations. Using the suggestions listed below will help in making the records easy to read:

1. Always follow a particular line around until you return to the point of beginning. The area within that boundary is the land affected by the action identified.
2. To find the notation for a particular area, know what that line stands for.
3. Identification of the land circumscribed usually appears in the lower center of the area involved. If space does not allow a lower center placement of the notation, it may appear to one side or even outside the area circumscribed and arrowed in.
4. When the plat is too small to adequately depict the status, a supplemental plat is prepared on a larger scale. If a supplemental plat has been made, the plat will so indicate.

## Source Documents

Title information on plats are taken from microfilm copies of documents such as patents, withdrawal orders, State selection lists, etc. These microfilm records are kept in the State Office Land Records. Paper copies of source documents, as well as copies of plats and indexes may be purchased from the Land Records. Please ask for a current copy fee schedule.
