To Oregon Senators, Representative, Governor, County Commissioners, and Bureau of Land Management (BLM):







The WOPR would dramatically increase clearcut logging, establish noisy Off Highway Vehicle parks, and prioritize timber sales and OHV use at the expense of virtually all other life-sustaining, community and property values.
