


**JUSTIFICATION FOR OTHER THAN FULL AND OPEN COMPETITION  
FAR PART 6**

1. IDENTIFICATION OF THE AGENCY AND CONTRACTING ACTIVITY (FAR 6.303-2(b) (1)). Bureau of Land Management, Medford District, 3040 Biddle Road, Medford, Oregon 97504

2. NATURE/DESCRIPTION OF THE ACTION BEING APPROVED (FAR 6.303-2(b) (2)). Enforce the civil, and criminal law of the State and/or county on the public lands, waters, roads, and trails administered by the BLM as a sole source to Josephine County Sheriff's Office, 1901 NE F Street, Grants Pass, Oregon 97526 to be procured as a firm fixed price.

3. DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEEDS (INCLUDING THE ESTIMATED VALUE) (FAR 6.303-2(b) (3)). The Government requires law enforcement and protective services through specific patrols to assist the BLM in the administration and regulation of preservation of public order, protection of resources, safety, and tranquility of the public lands administered by the BLM within Josephine County, Oregon.





4. IDENTIFICATION OF STATUTORY AUTHORITY PERMITTING THE OTHER THAN FULL AND OPEN COMPETITION (FAR 6.303-2(b) (4)). The statutory authority permitting the other than full and open competition is 10 U.S.C. 2304(c) (1) or 41 U.S.C. 253(c) (1) under FAR 6.302-1 - Only one responsible source and no other supplier or services will satisfy the agency requirements. Sworn personnel assigned to duties on the public lands will be regular employees of the County Sheriff's Department who have complied with the minimum standards as required by the Oregon State Police Officers Standards and Training Council; and that such officers shall not be in violation of the provisions of 18 U.S.C. 922, which prohibits persons convicted of a misdemeanor domestic violence crime from possessing firearms or ammunition.

5. DEMONSTRATION THAT THE PROPOSED CONTRACTOR'S UNIQUE QUALIFICATIONS OR THE NATURE OF THE ACQUISITION REQUIRES USE OF THE AUTHORITY CITED (FAR 6.303-2(b) (5)). The Josephine County Sheriff's Department is the only responsible source to provide, which has the authority required to enforce the civil and criminal laws of the State and/or county on the public lands, waters, roads, and trails administered by the BLM. Because the Josephine Sheriff's Department personnel have the necessary training and have met the Oregon State law enforcement standards, they have demonstrated to have the necessary unique qualifications and authority that other civilian security agencies will not have.

6. DESCRIPTION OF THE EFFORTS MADE TO ENSURE THAT OFFERS ARE SOLICITED FROM AS MANY POTENTIAL SOURCES AS IS PRACTICABLE, INCLUDING WHETHER A NOTICE WAS OR WILL BE PUBLICIZED AS REQUIRED BY SUBPART 5.2 AND IF NOT, WHICH EXCEPTION UNDER 5.202 APPLIES (FAR 6.303-2(b)6)). A synopsis of this action will be posted; however, a solicitation will not be posted because no other sources will be sought for this service contract, in accordance with FAR Part 5.202(10). The Josephine County Sheriff has demonstrated the unique and cooperative nature to perform the required services in conjunction with the Oregon State Police Officer Training and Standards and the BLM law enforcement procedures and policies, and soliciting other sources at this time is not practical or possible.

7. DETERMINATION BY THE CONTRACTING OFFICER THAT THE ANTICIPATED COST TO THE GOVERNMENT WILL BE FAIR AND REASONABLE (FAR 6.303-2(b) (7)).
