



JUSTIFICATION FOR OTHER THAN FULL AND OPEN COMPETITION
FAR PART 6

1. IDENTIFICATION OF THE AGENCY AND CONTRACTING ACTIVITY (FAR 6.303-2(b)(1)). Bureau of Land Management, Oregon State Office, 1220 SW 3rd Avenue, Portland, Oregon.

2. NATURE/DESCRIPTION OF THE ACTION BEING APPROVED (FAR 6.303-2(b)(2)). Purchase Order for law enforcement services for Douglas County, Oregon as a sole source award to Douglas County Sheriff's Office, 1036 SE Douglas Avenue Room 220, Roseburg, OR 97470-4271, to assist the Bureau of Land Management (BLM) in the administration and regulation of the use and occupancy of public lands, to be procured as a firm, fixed price commercial items service contract.

3. DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEEDS (INCLUDING THE ESTIMATED VALUE) (FAR 6.303-2(b)(3)). The Government requires obtaining law enforcement services through specified patrols to assist the Bureau of Land Management (BLM) in the administration and regulation of use and occupancy of the public lands, waters, roads and trails within the confines of Douglas County, Oregon.




4. IDENTIFICATION OF STATUTORY AUTHORITY PERMITTING THE OTHER THAN FULL AND OPEN COMPETITION (FAR 6.303-2(b)(4)). The statutory authority permitting the other than full and open competition is 10 U.S.C. 2304(c)(1) or 41 U.S.C. 253(c)(1) under FAR 6.302-1 - Only one responsible source and no other supplier or services will satisfy the agency requirements.

5. DEMONSTRATION THAT THE PROPOSED CONTRACTOR'S UNIQUE QUALIFICATIONS OR THE NATURE OF THE ACQUISITION REQUIRES USE OF THE AUTHORITY CITED (FAR 6.303-2(b)(5)). Although law enforcement services can be considered commercial by service category, the Douglas County Sheriff's Office is the only responsible source with jurisdiction to enforce the civil and criminal laws of the state of Oregon and Douglas County on the public lands, waters, roads and trails administered by the BLM. Douglas County Sheriff's Office deputies have undergone the required training as prescribed by the Oregon State Department of Public Safety Standards and Training and the BLM law enforcement procedures and policies. Douglas County Sheriff's Deputies possess the required qualifications and unique authority that other civilian security agencies do not have.

6. DESCRIPTION OF THE EFFORTS MADE TO ENSURE THAT OFFERS ARE SOLICITED FROM AS MANY POTENTIAL SOURCES AS IS PRACTICABLE, INCLUDING WHETHER A NOTICE WAS OR WILL BE PUBLICIZED AS REQUIRED BY SUBPART 5.2 AND IF NOT, WHICH EXCEPTION UNDER 5.202 APPLIES (FAR 6.303-2(b)(6)). A sole source notice and the justification was publicized on the Federal Business Opportunity website on August 16, 2013 for solicitation L13PS01059 for Law Enforcement Services giving potential sources fifteen (15) days to respond. No other sources will be sought for this service contract.

7. DETERMINATION BY THE CONTRACTING OFFICER THAT THE ANTICIPATED COST TO THE GOVERNMENT WILL BE FAIR AND REASONABLE (FAR 6.303-2(b)(7)). The Douglas County Sheriff's Office will be invoicing the BLM for actual costs for service provided based on the following rates:
