



Wallowa & Grande Ronde Rivers Outfitters & Guides List 2009



A **federal** Special Recreation Permit (SRP) may be required of commercial guides conducting activities on the Wallowa & Grande Ronde Rivers, depending on the State in which the use occurs:

IN OREGON

Between Minam and the OR-WA state line, a SRP is required for all commercial activities.

IN WASHINGTON

From the OR-WA state line to the Snake River, a SRP is required for commercial activities *ONLY* if use occurs on *Bureau of Land Management (BLM) lands above the average high-water mark.*

NOTE: If the trip originates in Washington, and does *not* utilize BLM lands above the high-water mark, a federal commercial use permit (SRP) is *not* required.
