Please submit form by mail or email to the BLM Fillmore Field Office, BLM West Desert District Office, or the Little Sahara Recreation Area. The form can also be placed in the fee envelope with payment upon entering the Little Sahara Recreation Area.

The BLM will accept credit card, cash, or check. To pay by credit card, call the BLM office that you submitted the application to during normal business hours: Monday – Friday, 8 a.m. – 4:30 p.m., except federal holidays. When submitting your application, please include a return mail address. The Seasonal Vehicle Use Permit will be mailed to the address you provided.

Fee:
