Failure to comply, in accordance with Title 43 Code of Federal Regulations and H-2930-1 Recreation Permit Administration, may result in permit revocation. In addition, failure to comply by you and/or any member of your group may result in confiscation of season pass, and eviction from LSRA by authorized law enforcement officers.
