Melissa – A sources sought was issued and is now closed as of approximately three minutes ago

- The results and information from the sources sought will be reviewed and we will move forward with working on our requirements
- We will work on putting out a solicitation, determining our requirements and then working on an award before the current agreement expires
- Nick H. once something goes to contracting you should only be dealing with the people in contracting. A sources sought is your providing information,

however, once in the procurement process information should only be sent to the contracting officer.

Nick D. – So there is no issue if I send information to CRLP member's right?

- Melissa That is totally your decision, it's just within the BLM information flow needs to go to Acquisition and then acquisition's will distribute information as necessary.

Melissa – Nick do you have any questions?

- Nick D. can you expand on what will occur during the next thirty days through possibly the next one hundred eighty days?
- Melissa the procurement process was market research obtaining information on the types of contracts that may be used, small businesses, and the acquisition structure
 - Responses received from the sources sought we aide me in determining if small businesses vs large businesses that can help me do this
 - The information gathered will help determine my acquisition strategy. I will use the information to determine how I will structure the solicitation to come up with the requirements in order to have something in place by April 2018.
 - We are very well aware of the time constraints that are ahead of us and how it ends March 31, 2018. We are working diligently to get things moving. Nick I want you to know that I will keep you in the loop as things are made public and I am posting things out there.

b) Closure Activities

Sam – A second round of proposals from GSA has been received

- The GSA closure activities will conduct the clearing of the surface rights as well as the right of ways along the pipeline.
- We are moving forward with the environmental phase I and environmental assessment in order to actually dispose of the property according to GSA procedures
- Second phase has been sent forward, it's been approved and funding has been put into it, we are now well into this phase of the pipeline rights of way and a clear sale of the property
- The assessment and surface rights are well underway they will be getting subcontracting and getting the contractors in, they will be getting a clear title from the county courthouses so we can document what is for sale

- The high level bucket items being considered are the mineral resources and the reservoir, then the surface equipment and the pipeline itself
- GSA is aware that many of the potential buyers are beginning to ask questions what exactly are thy purchasing, I am trying to set up conference call and will be sending emails to interested parties as well as storage contract holders. Potential dates for the conference call/emails is April 18, 2017 or the following week of April 24th, 2017
- Sam- Any questions on what I discussed?
 - Nick H. What is included in the sale and defining it is really Important
 - Sam we are trying to put together a reporting mechanism such as a frequently asked questions bulletin, and I am trying to get permission to post on our website describing what is on the sale between now and the year 2021.
