Trail Etiquette

- Stay on the trail - follow the switchbacks even if you see a more direct route.
- Pedestrians have the right of way over bikers, and both hikers and bikers must yield to horses, and OHV's Yield to all others.
- Do not disturb wildlife or the environment along the trail. Disturbing wildlife or damaging the environment destroys the trail for all of us.

Keep it Safe

- Always tell someone where you will be and your expected return time.
- Keep an eye to the sky, summer rains can make getting around difficult.

Be a Responsible OHV User

Motorized travel in this area is limited to designated roads and trails.

When using your ATV, motorcycle or other motorized vehicle:

- Do not create new roads or trails by riding off designated routes.
- Park at existing parking areas and pull-offs, within 50' of centerline, unless marked closed.
- Prevent resource damage by preventing undue damage to or disturbance of the soil, wildlife, wildlife habitat, improvements, cultural or vegetative resources or other authorized uses of public lands.
- Proper Equipment - Remember before sunrise and after sunset **headlights and taillights** are required. OHV's must have a **spark-arresting device** on public lands. The decibel limit for the Wolford Area is 96db. Have your vehicle checked! Users operating a vehicle louder than 96db may be ticketed.
- Register your OHV - and follow all state laws. Off-Highway Vehicle operators must have a registration or permit. For more information call Colorado State Parks at 303-866-3437.

Welcome to Wolford Mountain

The public lands within the Wolford Mountain area offer a variety of recreational opportunities including hiking, wildlife viewing, picnicking, sightseeing, fishing, hunting, horseback riding, mountain biking, camping and vehicle touring.

The area's existing network of primitive roads and trails has been established over many years by local ranchers, recreationists, cattle, and wildlife. In January 2005, the Kremmling Field Office completed designations for the road and trail network, resulting in a system of route opportunities for travel by foot, horse, mountain bike, motorcycle, ATV, and 4x4.

Each road and trail should be signed for the appropriate type of use; however if for some reason a route **does not have a sign indicating the type of use allowed, then the route should be considered CLOSED.**

Travel in the Wolford Area is Limited to Designated Routes

**Summer Use Period
April - 15 - December 15**

Camping

- Use existing campsites. Parking for camping is limited to 50 feet from centerline of the road or trail, unless marked closed.
- Camping is limited to 14 days.
- Observe all open fire restrictions, Local, State and Federal.
- Use fire wisely - use existing fire rings, never leave fires unattended, Burn logs to ashes, then add water and mix and make sure it's out before you leave. Firepans or stoves are recommended when camping on BLM. Firepans may be banned during high fire danger periods.
- Collect Wood only from dead and down trees, or use wood you packed in for campfires.
- Pack out your trash (and a little extra). Do not put cans, bottles or aluminum foil into a fire ring.
- Dispose of human waste properly.

Non-motorized Recreation Opportunities

The Wolford area offers year-round non-motorized recreational opportunities that include wildlife viewing, hiking, mountain biking, and horseback riding.

Hiking/Horseback Riding/Mountain Biking:

Numerous primitive roads and trails provide opportunities for these uses; however users should stay on designated routes and existing trails.


Hunting

- Parking for hunting or game retrieval is limited to 50 feet from centerline of the road or trail, unless marked closed. No motorized travel beyond this is allowed for game retrieval.
- Follow State Game Laws - It is illegal to shoot from or use a motor vehicle to hunt, chase, harass, or drive wildlife.
- Remember to unload Firearms - by Law, firearms are to be **completely unloaded** while being carried in or on an OHV.
- Minimize motor vehicle use when on a hunt. Motors startle game, forcing them to flee to more secluded areas, predominantly private land. Where you go and how you get there could mean the difference between a successful hunt and an unsuccessful hunt!

All users, please:

- Pack out all trash and dispose of it properly.
- Respect other users.
- Respect private property - ask permission first!
- Completely extinguish cigarettes and properly dispose of them.
- Report illegal activities to the BLM or local law enforcement.
