**Nick D.**-Antitrust guidelines apply. If there are any questions, please let me know.

Any update on COVID?

**Sam B.**-We have not gotten anything specifically from the BLM. There is an executive order mandating the wearing of masks on federal property. No positive cases reported this week.

**Nick D.**-Moving on to operational side. Yesterday around 1400 pounds.

**Mark M.**-Pipeline did go up overnight about 40 pounds. Now we are at 1407. We still have Bivens A6 on standby. Bivens A6 has a head pressure of 254 pounds. No equipment problems to mention at the moment. We have been having trouble with the 3 A/C units in the old control room so we will be sending you market research to get those replaced.

**Nick D.**-Is there any update on the campaign mode?

**Sam B.**-We are looking at the demand, I still need to get to the understanding of how we will do campaign mode and make sure it will not cause any problems. So, there is not any change right now. We will talk about it again next week to see if there are any changes.

**Nick D.**-We are still looking at the middle of March for Brad B. to do projects and maintenance. Are there any issues with supply or anything like that? Brad, are you looking at a week for your work?

**Nick D.**-I'm just interested to hear if there is anything that we need to get reserved early.

**Brad B.**-Did we ever figure out if we can put one of those mobile trailers out there where the guard shack is.

**Sam B.**-I'm not aware if the landowner has anything to say about having a temporary building out there. Does anyone at the plant know if anyone has talked to the landowner about that?

**Brad H.**-I haven't heard anything.

**Nick D.**-I think it is a COVID thing it hasn't been done before.

**Sam B.**- I think we would have to talk to the landowner about having a building out there.

**Brad B.**-We would use a generator and would like to have it there a few months.

**Sam B.**-So it is semi-permanent it could be 6 months.

We just need to make sure with the landowner and someone from CRLP would need to tell us where we would want to put it.

**Nick D.**-Is there a restriction from having it within the fence line?

**Sam B.**-There would be safety consideration and risk assessment done. There would need to be consideration for power and things like that.

**Nick D.**-Ok Brad will take the lead with that and we will discuss it more once we have more information. John you probably won't want to do your work right before or right after Brad's team so we give the pipeline time to pack.

I didn't see anything on bypasses this week.

**Mark M.** and **Brad B.**-It is the same.

**Sam B.**-It looks like we are ok with the DGA solution with the winter weather that is coming in.
