## STANDARDS FOR PREPARING BLM ANNUAL CULTURAL RESOURCE REPORTS

- 1. **Title:** List the company name, the Permit number under which the work was conducted, and the year.
- 2. Project Information. List the project names, their BLM serial case file numbers, Project Title, Acres Inventoried in BLM, total acres inventoried, number of BLM sites, and disposition of original records and data. If no field work was completed, simply state "no fieldwork was completed on BLM-administered lands in Utah in [YEAR]", and delete the remaining categories. Your annual report is now complete.
  - a. If collections were deposited in a repository, please include <u>Bureau of Land</u>
    Management Confirmation of Museum Collection Deposition Statement
