Major Policy Initiatives for Upcoming 30 Days

I. Notable legislation, rulemaking, and guidance under consideration

WITHDRAWAL OF CLEAN POWER PLAN TO OMB FOR REVIEW

EPA will send a proposed withdrawal of the rule to the Office of Management and Budget for review. EPA is also working with the Department of Justice to respond to the D.C. Circuit Court's request for a response to either hold the associated litigation in abeyance or remand the rule back to EPA.

By May 22: Send draft to OMB.

II. Reports to the President in progress

SUBMIT BEARS EARS MONUMENT RECOMMENDATION TO PRESIDENT

The President requested an interim report within 45 days, reviewing past national monument designations. The Secretary of Interior is to consider, among other things, whether monuments conform to the original purposes and requirements of the Antiquities Act of 1906; the concerns of affected citizens and State, local, and tribal officials; and the impacts of designations on multiple-use requirements for Federal lands, including ranching, recreation, and energy development.

Early June (Report to WH): Secretary Zinke is in Utah this week to meet with tribal leaders, Congressional delegation and state and local officials to gather input on the monument designations and comply with the President's Executive Order.

III. Upcoming major Congressional engagements

INCREASE CHOICE IN HEALTH CARE OPTIONS FOR VETERANS

Support the Veterans Choice Act of 2017, to provide veterans more options for care in the community when VA Medical Centers do not meet their needs.

May 15: Secretary Shulkin and Dr. Yehia will testify before the Senate Committee on Veterans Affairs (SVAC).

2016 SUPERFUND REPORT TO CONGRESS

EPA is responsible for reviewing Superfund remedial actions at least every five years where contaminants remain on site above levels that allow for unlimited use and unrestricted exposure. EPA prepares an annual report to Congress providing a list of sites and information about sites where additional work is required.

May 26: Anticipate going to OMB; After OMB completes review, EPA will submit to the Hill.

IV. Major Legal Actions Pending

MURRAY ENERGY CORPORATION, ET AL V. EPA, NO. 16-2432

In this appeal of *Murray Energy Corp. et al. v. McCarthy*, (N.D. W. Va. 2016) in the Fourth Circuit, the Plaintiff alleged and the district court held that the Agency has failed to perform a non-discretionary duty under Section 321(a) of the Clean Air Act to evaluate potential loss or shifts of employment within an industry caused by regulations implementing the Act. DOJ and the Agency's position is that the district court's order goes far beyond what the statute requires of the Agency and runs the risk of requiring the Agency to identify facilities at risk of closure and thus compounding the market pressure to which those facilities are subject.

May 15: Comprehensive compliance plan due to district court.
