(1) Describe current conditions: (Include boundary features, land ownership, size, location, topography, vegetation features and summary of major human uses/activities).

The inventory unit is located in Grant County approximately 1 mile south of the town of Canyon City. It is bordered on the south side by USFS Strawberry Mountain Wilderness Area and private land. It is bordered on the north and east by private land, and on the west by the paved US Highway 395, road and utility ROWs and private land. The unit is 2,463 acres in size. The inventory unit is separated into two subunits by a constructed, maintained USFS Route # 333, which provides access to a trailhead for the Strawberry Mountain Wilderness.

Original Inventory

The lands in the 2007 inventory include lands previously inventoried for their wilderness characteristics under Section 603 of FLPMA. In 1979, the initial BLM OR/WA Wilderness Inventory effort addressed these lands, and in 1980 the Intensive Wilderness Inventory for Strawberry Mountain Parcel B (OR-2-98B) addressed these lands in detail. The Final Intensive Inventory Decisions in November 1980 dropped all of Parcel B within the Strawberry Mountain Inventory Unit from further study stating that "Subunit B [and ...] were eliminated because they contain substantially noticeable imprints of man's work and cannot be considered as being in a basically natural condition. These areas are primarily affected by the impacts of various mining operations as well as the impacts of past logging operations (Subunit B). These impacts are substantially noticeable and should not be included within the wilderness study areas."

Description of Current Conditions

The lands that were dropped during the original wilderness inventory are being re-inventoried in 2007. The 2007 subunits labeled as A and B make up the original Subunit B that were dropped from further wilderness consideration in 1980. Today's computer-generated acreage figure for these three parcels combined is 2,463 acres.

Location of Subunits A and B:

Subunit A is bordered on the south side by general management USFS lands and on the west side by US Highway 395, several road and utility ROWs, and private lands. The Subunit is bordered on the east side by the constructed, maintained Forest Road 333 and private land, and on the north side by private land. The subunit is 2,072 acres in size.

At 2072 acres, Subunit A lacks sufficient size to be considered as wilderness and does not meet one of the exceptions for small size. For this reason, Subunit A will not be discussed further in this document.

Subunit B is bordered on the west side by the constructed, maintained Forest Road 333, on the south side by a combination of USFS Strawberry Mountain Wilderness Area and general management USFS lands, and on the east side by private land.

Location of Subunit A: Portions of or all public lands in T. 14 S., R. 31 E., Sections 1, 11, 12, 13, 14; T. 14 S., R. 32 E., Sections 6, 7.

Location of Subunit B: Portions of or all public lands in T. 14 S., R. 32 E., Sections 6, 7 and 8.

Description:

Subunit B is located on the east flanks of Little Canyon Mountain (5,682 feet). It includes Little Pine Creek, a perennial stream which flows from south to north through the subunit, and ridges on either side of the creek drainage. Vegetation is mixed conifer forest. A past wildfire in the adjacent wilderness area burned approximately 80 acres of the subunit, leaving areas of standing and fallen grey-colored snags. Wildlife species include elk, mule deer, bobcat, quail and grouse. Numerous historical resources are present in the Little Canyon Mountain area, left behind from years of historical mining activities, including the remains of wooden trough water transport systems, mine shafts, cabins, etc. The BLM Visual Resource Management Class of Subunit B is Class II.

A portion of Subunit B is currently authorized for commercial grazing under BLM permits # 4056. There are several active mining claims within the subunit, and timber has been harvested repeatedly. Most recently, timber was thinned in 2004 as part of BLM's 2003 Little Canyon Mountain Fuels Reduction Project. Public access is available via USFS Route #333 and there are several unmaintained vehicle routes within the subunit. The 2003 Little Canyon Mountain Fuels Reduction Project closed some unmaintained vehicle routes especially in creek drainages, including some of the routes that likely existed during the original wilderness inventory (See Map labeled 2.4). Recreational uses of this area include hunting, hiking, horseback riding, and OHV riding.

Describe:

Subunit B is not in a natural condition. It has been substantially modified by man due to years of human activities including placer mining, timber harvest, and road building. Timber has been harvested and timber haul roads constructed. Past and current mining claims have left imprints including mine shafts, tailings piles from hydraulic mining, and roads. Even though the 2003 Little Canyon Mountain Fuels Reduction Project did close some of the unmaintained vehicle routes that likely existed during the original wilderness inventory, the 2007 inventory confirms that the unnatural condition of these lands that was present during the 1980 inventory is still present today.


Map 2.4 - Roads Proposed for Closure
