ROUTES MONITORED YEAR 1 OF THE SECOND 3-YEAR MONITORING CYCLE:

Pursuant to the 2013 Protocol Monitoring Plan, as amended January 2017, for Year 1 of the second 3-year monitoring cycle, commencing August 2016 BLM completed field inspection and data recordation on 118 miles of field sample routes, and 51 miles of aerial sample routes. Table 1 lists the routes field monitored and Table 2 lists the routes aerially monitored in Year 1 of the second 3-year monitoring cycle. These routes are depicted on Attachment 2 – Map, Year 1 Protocol Monitoring of the Second 3-Year Monitoring Cycle and color-coded for field versus aerial monitoring. No issues were encountered during monitoring and no deviation or changes in the protocol or variables were determined to be necessary.
