APPLICATION FOR BLOOMINGTON CAVE ENTRANCE PERMIT

Permit Requirements:

- 1. Maximum Group Size 10 (including Group Leader)
- 2. Minimum Group Size 3 (including Group Leader)
- 3. Group Leader must be 18 years of age, have adequate caving experience, and have knowledgeable of established cave safety practices and cave conservation measures.
- 4. Each person in the caving party will wear a safety helmet (hard hat) with chin strap at all times while in the cave.
- 5. Each person in the caving party will have in their possession at least three sources of light, one of which will be attached to the helmet. Candles, matches and cigarette lighters are <u>not</u> acceptable as second light sources.
- 6. Boy Scouts of America (BSA)-sponsored groups must have a minimum number of 5 persons per group, with two Group Leaders, one of whom must be at least 21years old.
- 7. The BSA Group Leaders must have adequate caving experience and be knowledgeable of established safety practices and cave conservation measures.
- 8. Boy Scout leaders must provide BLM a copy of their BSA-approved tour permit.
