<u>Vegetation Features:</u> Davis Bay Island has some lichens but most all rocks are marine, intertidal habitat with a variety of seaweeds and marine intertidal species.

<u>Major human uses/ activities:</u> Wildlife viewing, kayaking, non-motorized and motorized boating occurs in the area. Intertidal tide-pooling occurs as well.

<u>Other items:</u> There are several USFW, San Juan Marine National Wildlife Refuge Islands nearby within 1 mile. There are also protected islands nearby as part of The Nature Conservancy.
