

- SPECIFIC LEGISLATION

FLPMA – Federal Land Policy and Management Act of 1976

SALES

- $-\sec.203$
 - Competitive (preferred)
 - Modified Competitive
 - Direct Sale (must meet special criteria)
 - $-\sec.209$
 - Conveyance of minerals

LAND EXCHANGES

sec. 206 of FLPMA (as amended by FLEFA)

May exchange land or interest in land

- Lands must be within same state
- Must be equal in value (within 25%)
- Single transaction involving two parcels
- Assembled (single transaction multiple parcels)
- Assembled (multiple parcels, multiple transactions over time)
- State Exchanges
- BLM as a Land Bank (when needed by other agencies)

ACQUISITIONS – sec 205 of FLPMA

- Easements (access, conservation)
- Land (usually within or abutting designated areas)
 - NM, NCA, ACEC, SRMA
- Interest in land (minerals, water, etc.)
- Reciprocal rights-of-way

FUNDING SOURCES FOR ACQUISITIONS

Land and Water Conservation Fund (LWCF)

- Created by Congress in 1965
- Uses non-tax revenue sources
- Supports recreation and conservation goals
- Benefits 4 Federal Agencies, States, and Others
- Willing Sellers / Cooperating Organizations
- Currently up for re-authorization
 - Signs of bipartisan support in general
 - Issues Allowable uses, funding levels, beneficiaries



2014 BLM Acquisitions

- Canyons of the Ancients National Monument (\$1.77M 1563 acres)
- Sarvis Creek/Upper Yampa Hunter/Angler Access (\$1M 47 acres)

Recent BLM Expenditures in the NW District

- Dominguez-Escalante National Conservation Area (\$3.5M in 2012)
- Dominguez-Escalante National Conservation Area (\$575K in 2013)
- Gunnison Gorge National Conservation Area (\$856K in 2008)
- McInnis Canyons National Conservation Area (\$1.3M in 2005-06)

Upcoming Acquisitions

- Canyons of the Ancients National Monument (\$1.2M 600 acres)
- Blanca Wetlands ACEC/SRMA (\$6.35M for 12,838 acres)*

Management of Lands & Resources (MLR)

- Money annually appropriated by Congress to manage the Public Lands
- Realty, Minerals, Planning, etc.
- Can it be used for acquisitions?
 - Interest in land only (e.g., access easement)
 - Prohibited by law to purchase land

FLTFA

- Authorized in 2000 / Sunsetted in 2010
- Reauthorized in 2010 for 1 year, but expired again
- Currently FLTFA is not authorized
- Allowed for the proceeds of Federal land sales to be used for acquisition costs (all) within the same state
- 4% share allocated to the state
- 96% to Federal agency
 - 80% used for purchase of property
 - 20% for related acquisition costs (appraisals, ESAs, staff)

R&PP

- Enacted in 1920's Amended twice since
- Purpose, who qualifies?
- What qualifies, what doesn't?
- Land can be leased or sold (or both)
- Some uses eligible for sale only (1988 amendment)
- Purchase price from 10% discount to free
- Plan of Development & implementation req'd

R&PP (cont.)

- Reverter Clause
- What triggers reverter?
- Can land be transferred?
- Can the use change?
