- (1) The performance goal for FY 2013 was to have 97% of the BLM's organizational units rated in good safety, health, and environmental condition which is one percent higher than last year's performance.
- (2) The above data includes audits performed from October 1993 through June 2013 and responses from the field on the findings from those audits through July 2013.
- (3) FY 2013 is the ninth fiscal year in which an organizational unit must have all its high priority CASHE findings completed to be rated in good condition. This standard has been phased in since FY 2000 when an organizational unit could have up to five high priority findings and be rated in good condition. Each fiscal year since FY 2000 the good condition standard has been reduced by one high priority finding until it reached zero in FY 2005.
- (4) FY 2013 is the fifth year Radio Infrastructure (RI) CASHE audit findings count towards determining whether an organizational unit is rated in good condition.
- (5) In FY 2013 an organizational unit must have zero incomplete high priority traditional CASHE findings and no more than one incomplete high priority RI CASHE Radio finding to be rated in good condition. This standard has been phased in since FY 2009 when an organizational unit could have up to five high priority findings and be rated in good condition. Each fiscal year since FY 2009 the good condition standard has been reduced by one high priority finding until it reaches zero in FY 2014.
- (6) In FY 2014 an organizational unit must have zero incomplete high priority traditional CASHE findings and zero incomplete high priority RI CASHE findings to be rated in good condition.
