A national contract for the dewormers and vaccines listed above will continue to be administered by WO-260. An additional dewormer moxidectin will be added to the National Vaccine contract to provide facility managers a second type of deworming product to act against a broader array of internal parasites. Multiple field "ordering officials" will order and receive shipments for their respective short-term holding facilities. The WO-260 will receive all invoices and prepare requisitions for payments to the contractor. Vaccines and dewormers will be sent directly to the ordering facilities.
