Description (describe the boundaries of the area--wilderness inventory roads, property lines, etc.): The Evan's Mountain area of this Opal Creek subunit is approximately 278 acres located in T8S, R4E, Section 29, Marion County, Little North Santiam 5th field watershed. The subunit boundaries are a combination of roads, past harvest, and ownership boundaries. The Opal Creek Wilderness, a 20,454 acre designated Wilderness area administered by the Willamette National Forest, Detroit Ranger District, is the eastern boundary of this land. The Omnibus Parks and Public Lands Management Act of 1996 designated the area. Boundaries were derived from a citizen's proposal during scoping for the Western Oregon Plan Revisions. Current BLM wilderness characteristic policy and field verification has moved boundaries based on FOI (Forest Operations Inventory).

The Evan's Mountain area of the Opal Creek subunit boundary roads are non-gated paved and graveled forest roads with semi regular maintenance. Timber harvest, Forest Operations Inventory class, and roads will determine the boundary. The southern boundary is State owned lands.

The Elkhorn Creek area or the southern portion of the original inventory unit (lands within T9S R4E Sections 5-7 and 17; T9S, R3E Section 1) is adjacent to the USFS-administered Opal Creek Scenic Recreation Area land that is to the south of the Opal Creek Wilderness and bisected by roads. The USFS stated they will not pursue wilderness designation of this area. Because this area is not directly contiguous with the Opal Creek Wilderness, it does not meet the size criteria and has been dropped from this inventory unit.

With these boundary adjustments to the Evan's Mountain area and the dropped Elkhorn Creek area, the acreage of the Opal Creek subunit (OR08-1 (b)) is now 278 acres added to the existing Opal Creek Wilderness.

2) Does the area appear to be natural?

Description (include land ownership, location, topography, vegetation, and summary of major human uses/activities):

The Evan's Mountain area is currently BLM-administered Oregon and California Revested Lands, and classified as Connectivity (CONN) Land Use Allocation (LUA) in the Salem BLM's current Resource Management Plan.

Of the 278 acres of this section proposed for addition to the adjacent Opal Creek Wilderness, approximately 94 acres (or 34 percent) are currently classified as "withdrawn" from timber production; likely due to large rock outcroppings and ledges ranging from 1,360 to 3,180 feet in elevation. Dispersed recreation occurs in the area.

These stands consist of fully stocked mid to late mature seral stage Douglas-fir ranging in age from approximately 80 to 150 years. There are no records of any previous harvest or timber management activities.

3) Does the area (or the remainder of the area if a portion has been excluded due to unnaturalness and the remainder is of sufficient size) have outstanding opportunities for solitude?

Description (describe the area's outstanding opportunities for solitude): Although small in size, the unit provides outstanding opportunities for solitude in association with the adjacent Opal Creek Wilderness Area. The area is one mile by 0.70 of a mile wide. You may hear louder sounds from the surrounding environment to the north, south and west of the area from management practices on non wilderness lands however one can experience solitude due to terrain and heavy vegetative cover in association with the adjacent Opal Creek Wilderness.

4) Does the area (or the remainder of the area if a portion has been excluded due to unnaturalness and the remainder is of sufficient size) have outstanding opportunities for primitive and unconfined recreation?

Description (describe the area's outstanding opportunities for primitive and unconfined recreation): Overall, the unit provides outstanding opportunities for primitive and unconfined recreation in association with the adjoining Opal Creek Wilderness lands. The area has no trails or developed recreation sites. Dispersed non-motorized recreation occurs in the area. The unit, in conjunction with the contiguous Opal Creek Wilderness and Scenic Recreation Area, offers outstanding primitive recreation opportunities that draw visitors from outside the region.

5) Does the area have supplemental values (ecological, geological, or other features of scientific, educational, scenic or historical value)?

Description of Supplemental Values:

Timber

A planned timber sale (called "Evan's Mountain Thinning") is proposed directly west of the proposed subunit in section 29, with the current proposed wilderness addition boundaries adjusted to exclude this area. A main access road follows near the north-western boundary of this subunit (8-4E-30.0 road) is paved along portions of the road, and will be used as a main haul route for the "Evan's Mountain" thinning sale; proposed for sale in 2013.

All of the proposed additions in section 29, with the exception of the "withdrawn" acres, could be considered for current and future timber harvest opportunities according to the direction in the Salem District RMP pertinent to lands designed as CONN LUA (See RMP Appendix D-3). Some road construction would be necessary to access portions of the Evan's Mountain area for timber harvest, when other areas (about 60 acres) would only be accessible to log by helicopter. These areas were considered for treatment under the "Evan's Mountain" timber sale, but were dropped from the proposal. Other areas east of the 8-3-30.0 road just south of the "withdrawn" area could be available for timber harvest with additional road construction.

<u>Owls</u>

The Evan's Mountain subunit is primarily suitable habitat with some dispersal habitat within the proposed addition. This area is within the Provincial home range of two Northern Spotted Owl pairs, is the core area of one pair, and contains one site center.

Summary of Analysis^{*}

Area Unique Identifier: OR08-1 (b) Opal Creek Additions - Evan's Mountain

Summary

Results of analysis: A smaller portion of the Opal Creek Subunit contains wilderness characteristics – the Evans' Mountain area that is approximately 278 acres.

The inventory found that the Elkhorn area does not meet the size criteria – it is not adjacent to identified wilderness characteristics on USFS lands. The area is natural but does not contain outstanding opportunities for solitude or primitive and unconfined recreation.


